## SUMMARY AND RECOMMENDATIONS

This ordinance authorizes the City Manager to accept a cash award in the amount of \$75,000.00 and execute an agreement with Bexar County for the Ryan White Title I Health Education/Risk Reduction (HERR) Program of the San Antonio Metropolitan Health District (SAMHD) for the period January 1, 2003 through February 28, 2003. This ordinance will also establish a fund, adopt a budget, approve a personnel complement, and authorize payments for contractual services.

Staff recommends approval.

# **BACKGROUND INFORMATION**

Bexar County was awarded grant funds from the U.S. Department of Health and Human Services (USDHHS) to provide HIV/AIDS support Services to persons affected by HIV and AIDS, and their families, under Title I of the Ryan White Comprehensive AIDS Resources Emergency Act of 1990. The County has requested assistance from SAMHD to provide services to persons affected by HIV and AIDS, and their families who reside in the San Antonio HIV Service Delivery Area (HSDA) of Atascosa, Bandera, Bexar, Comal, Frio, Gillespie, Guadalupe, Karnes, Kendall, Kerr, Medina and Wilson counties. The County and SAMIID believe it would be in the best public interest to provide such assistance for activities under HIV Services Program Management.

These funds will be used to conduct the following scope of work:

- To inform and educate HIV positive individuals in the San Antonio Eligible Metropolitan Area (EMA) about current health care options and risk reduction activities.
- > To deliver outreach health education (treatment and adherence to medication) and risk reduction training to at lease 70 HIV positive individuals in the San Antonio EMA.

To develop current and relevant information, education and communication (IEC) materials on HIV/AIDS treatment resources, adherence to medication and risk reduction for the San Antonio EMA

The personnel complement for this program consists of one (1) full-time position, Health Program Specialist.

## **POLICY ANALYSIS**

Execution of this agreement with Bexar County and acceptance of this cash award will continue the long-standing practice of utilizing Federal, State and local aid to support the public health programs of the City and the residents of Bexar County.

# FISCAL IMPACT

This agreement with Bexar County provides \$75,000.00 in cash support for the Ryan White Title I Health Education/Risk Reduction (HERR) Program of the SAMHD. Acceptance of this agreement will place no demands on the City General Fund.

#### **COORDINATION**

The City Attorney's Office and the Office of Management and Budget, Risk Management Division have reviewed the contract with Bexar County. The Finance Department has approved the proposed project budget.

# **SUPPLEMENTARY COMMENTS**

The \$75,000.00 is carry forward money from the County's FY 2002/2003 fiscal year. The County issued a Request for Proposal (RFP) in January, 2003 and SAMHD was awarded the contract. Although the County's contract term date is January 1, 2003 through February 28, 2003, the contract was not received from Bexar County until June 19, 2003. Due to the July recess for City Council, this is the first opportunity for SAMHD to present the ordinance.

Provisions of the Ethics Ordinance do not apply.
