ORDINANCE AUTHORIZING THE EXECUTION OF A CONTRACT

CHANGE FROM THE TEXAS DEPARTMENT OF HEALTH

#### SUMMARY AND RECOMMENDATIONS

This ordinance authorizes the City Manager to accept a contract change from the Texas Department of Health (TDH) reducing funds previously provided by \$23,189.00 for the ongoing Sexually Transmitted Disease (STD) Staff Support Program of the San Antonio Metropolitan Health District for the period January 1, 2003 through December 31, 2003. This ordinance also authorizes execution of a contract change with TDH, revises the budget for the Public Health State Support Project 2003/2004 – Federal account and revises the personnel complement.

Staff recommends approval.

#### **BACKGROUND INFORMATION**

TDH provides annual assistance to the City to support core public health activities provided by the SAMHD. TDH has forwarded Contract Change Notice No. 05 as an amendment to the TDH contract previously accepted through an ordinance passed and approved on February 6, 2003. This amendment revises the budget of the STD Staff Support Program of the SAMHD. The STD Staff Support Program consists of personnel in the STD Clinic who conduct counseling to control and prevent the spread of sexually transmitted diseases, including HIV/AIDS and viral hepatitis.

Due to state fiscal constraints TDH has issued a contract amendment that will reduce the STD Staff Support Program budget by \$23,189.00. This reduces the personnel complement of the STD Staff Support Program by one position, the Health Program Supervisor. This position is presently vacant. TDH has indicated an interest in restoring the position with a Rapid Response Team (RRT) member, a new initiative, at a later date when funding can be identified. SAMHD is interested in the position

as an RRT member to function as a Disease Intervention Specialist (DIS) and is hopeful it will be posted in the 2003/2004 grant year.

#### **POLICY ANALYSIS**

Acceptance of this grant from TDH will continue the long-standing practice of utilizing Federal and State aid to support the local public health programs of the City.

#### FISCAL IMPACT

This TDH contract amendment will reduce the budget for the STD Program of the SAMHD by \$23,189.00 bringing the total budget of this activity to \$212,093.00. Acceptance of this contract change will place no demands on the City General Fund.

### **COORDINATION**

The City Attorney's Office and the Office of Management and Budget, Risk Management Division have reviewed the contract with TDH. The Finance Department has approved the proposed program budget.

#### SUPPLEMENTARY COMMENTS

Provisions of the Ethics Ordinance do not apply.
