OF HEALTH FOR THE STD PROGRAM

DATE: August 14, 2003

SUMMARY AND RECOMMENDATIONS

This ordinance authorizes the City Manager to execute a contract amendment that provides cash support totaling \$77,046.00 from the Texas Department of Health (TDH) to fund the ongoing Sexually Transmitted Disease (STD) Control Program in the San Antonio Metropolitan Health District (SAMHD) for the period September 1, 2003 through August 31, 2004. This ordinance will establish a fund for the project budget of the Public Health State Support Project 2003/2004 - State account, adopt a budget, and approve a personnel complement.

Staff recommends approval.

BACKGROUND INFORMATION

TDH provides annual assistance to the City to support core public health activities provided by the SAMHD. TDH has offered Contract Change Notice No. 06 as an amendment to the TDH contract previously accepted through an ordinance passed and approved on February 6, 2003. This amendment supports the Sexually Transmitted Disease (STD) Control Program of the SAMHD. The State STD Control Program along with Federal funding and funding from the City General Fund, provides diagnosis, treatment and partner notification for approximately 11,000 patients each year who visit the SAMHD for sexually transmitted diseases. This is one of three funding sources for this program.

The personnel complement consisting of three (3) positions for the program remains the same as last year.

POLICY ANALYSIS

Acceptance of this grant from TDH will continue the long-standing practice of utilizing Federal and State aid to support the local public health programs of the City.

FISCAL IMPACT

This TDH contract amendment provides \$77,046.00 in cash support for the STD Control Program of the SAMHD, and is the same as last year. Acceptance of this amendment brings the total cash support from TDH for the Public Health State Support Project 2003/2004 to \$1,018,405.00. Of this amount \$941,359.00 is for Federal programs passed through TDH and placed in the Public Health State Support Project 2003/2004 – Federal account. The remaining \$77,046.00 is provided through State revenue funds and accounted for in the Public Health State Support Project 2003/2004 (State) account.

Acceptance of this contract change will place no demands on the City General Fund.

COORDINATION

The City Attorney's Office and the Office of Management and Budget, Risk Management Division have reviewed the contract with TDH. The Finance Department has approved the proposed project budget.

SUPPLEMENTARY COMMENTS

Provisions of the Ethics Ordinance do not apply.
