SUMMARY AND RECOMMENDATIONS

This ordinance appropriates funds in the total amount of \$500 for environmental laboratory services in connection with the Salado Creek Hike and Bike Trail Phase I project, an authorized 1999 General Obligation Flood Control with Park Improvement Bond funded project, located in Council District 2.

Staff recommends approval of this ordinance.

BACKGROUND INFORMATION

This ordinance will provide compensation to Chemron, Inc., for engineering services related to the Salado Creek Hike and Bike Trail Phase I project. Due to an area of concern identified within the project limits, the Environmental Services Department conducted soil sampling along the proposed Salado Creek hike & bike trails to determine if the subsurface soils have been impacted by potential contaminants. Soil samples were analyzed by Chemron under an existing Purchasing Contract. Results from this sampling event identified impacted soils within the project limits.

The Salado Creek Hike and Bike Trail Phase I project includes the design for a hike and bike trail along Salado Creek from Willow Springs Golf Course to Comanche Park. This phase of the project is currently under design.

POLICY ANALYSIS

Approval of this ordinance will be a continuation of City Council policy to construct previously approved 1999 General Obligation Flood Control with Park Improvements Bond funded Capital Improvement Projects.

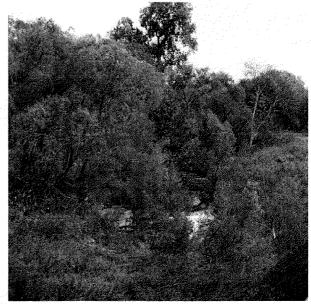
