SUMMARY AND RECOMMENDATIONS:

This ordinance will approve the parade permit and authorize the temporary closure of certain streets in connection with Chuys Children Giving to Children parade being held on Saturday, December 6, 2003. The run/walk will assemble at Ave. E. between 3rd and 6th St. and disband at Travis between Santa Rosa and Flores. The route is attached.

Staff recommends approval of this ordinance.

POLICY ANALYSIS:

This ordinance is consistent with the City policy requiring an ordinance where closures of public streets are requested.

COORDINATION:



FINANCIAL IMPACT:



