AMENDMENT WITH GOODWILL INDUSTRIES IN CONNECTION

WITH THE WELFARE-TO-WORK GRANT PROGRAM

SUMMARY AND RECOMMENDATION

This ordinance authorizes execution of a contract amendment with Goodwill Industries, awarding an additional \$75,000 in Welfare-to-Work grant funds from the U.S. Department of Labor.

Staff recommends the approval of this ordinance.

BACKGROUND INFORMATION

The City of San Antonio received a Welfare-to-Work grant award from the U.S. Department of Labor (DOL) in October of 1999. The grant focused on assisting the most needy populations within the Edgewood ISD neighborhood and the city's Empowerment Zone to obtain employment and training services. The City offered these services for two years through the ASCEND (Advocates Striving to Create Edgewood Neighborhood Development) program, and in August of 2001, issued a Request for Proposals to identify any agencies interested in providing Welfare-to-Work services. After an extensive review process, Goodwill Industries was selected.

Through this contract, Goodwill Industries serves over 300 participants through individual assessments, job readiness training, and employment placement. Participants are mostly women with children, have not completed high school or received a GED, and are unemployed. Participants exiting the program are employed and earning, on average, \$6.74 per hour.

POLICY ANALYSIS

Ordinance No. 95439, passed and approved on March 7, 2002, authorized execution of a contract with Goodwill Industries in an amount not to exceed \$1.4 million. This proposed action will increase the contract with Goodwill Industries to \$1.475 million. A contract amendment is required to award Goodwill Industries the additional \$75,000. This additional funding to Goodwill Industries represents all of the remaining Welfare-to-Work grant funding initially awarded to the City.

This additional funding will support a career enhancement project for 25 participants. Through this effort, Goodwill will provide participants with additional educational, life skills and career development training. The intended outcome of this enhanced program will be to ensure participants exit the program earning a minimum of \$7.25 per hour. Staff will work with participants to identify individual barriers to increasing their earning abilities and selecting appropriate education and career paths to promote further strides towards self-sufficiency.

FISCAL IMPACT

This contract amendment requires no General Fund support.

COORDINATION

The Department of Community Initiatives has coordinated activities with the U.S. Department of Labor, the City Attorney's Office, and the Finance Department.
