SUBJECT: ORDINANCE RATIFYING THE SUBMISSION OF A GRANT

APPLICATION AND AUTHORIZING THE ACCEPTANCE OF A GRANT FROM THE ALAMO AREA COUNCIL OF GOVERNMENTS (AACOG) FOR THE SUPPORTIVE SERVICES FOR THE ELDERLY

PROJECT (SSEP)

SUMMARY AND RECOMMENDATION

This ordinance ratifies the submission and acceptance of a grant from the Alamo Area Council of Governments (AACOG) in the amount of \$275,250, and the execution of a contract for the Supportive Services for the Elderly Project (SSEP) from October 1, 2003 through September 30, 2004. This contract is the first within a three-year funding cycle. This ordinance further adopts a budget and approves a personnel complement for FY 2003-2004, appropriates funds and authorizes the allocation of carry forward funds.

Staff recommends approval of this ordinance.

BACKGROUND INFORMATION

Since 1975, the Elderly and Disabled Services Division has administered the SSEP for the elderly of San Antonio and Bexar County. The program provides essential transportation services to seniors who are mobility-impaired and do not meet the VIA-Trans threshold for eligibility or do not live near a mainline bus route. These transportation services are primarily used for vital medical appointments.

The SSEP has a fleet of 12 vehicles (Attachment A) including seven, which are wheelchair lift-equipped. Vans are purchased with funds made available through Alamo Area Council of Governments (AACOG), the Texas Department of Transportation (TxDoT), and the City's General Fund.

Funds for the SSEP project in the amount of \$275,250 will be used to support staffing, general program support and vehicle maintenance.

POLICY ANALYSIS

This ordinance reflects a continuation of existing City policy to leverage grant funds for services to improve the quality of life of senior citizens of San Antonio and Bexar County and assist them in maintaining independent living. The performance measures are based on initial funding levels. Any additional funding received during the fiscal year, with the exception of capital equipment funds, will be directed towards additional one-way trips. The General Fund match for this grant is \$140,987. In FY 2003-04, the SSEP will continue to provide transportation services to seniors in the community, primarily for vital medical-related trips. In the past, approximately 82% of all trips provided to seniors have been medical-related. Approximately 2,100 elderly citizens will benefit from these services through 17,510 one-way trips in the 2003-04 program year. SSEP will coordinate with the Office of Elderly Affairs, City/County Joint Commission on Elderly Affairs and VIA to identify alternate transportation resources to augment service levels. The benchmark for customer satisfaction in FY 2003-2004 is 97%. In the most recent FY 2002-2003 customer satisfaction survey, 100% of respondents indicated they were very satisfied or satisfied with the services provided by SSEP.

This ordinance continues the current personnel complement of ten staff, which are outlined in Attachment IV of the ordinance.

FISCAL IMPACT

Since 1975, the Supportive Services for the Elderly Project has received an annual grant from the Texas Department on Aging (TDOA) through the Alamo Area Council of Governments (AACOG), acting as the local area agency on aging. Federal funds to TDOA are provided under Title III of the Older Americans Act of 1965, as amended. Historically, AACOG has provided an initial funding allocation at the beginning of the fiscal year and then has subsequently supplemented these allocations throughout the fiscal year as additional funds become available. AACOG's initial grant allocation for FY 2003-2004 is \$275,250. Additional funding is anticipated throughout the year. Donations from participants are accepted on a voluntary basis to help defray the City's cost to providing transportation services.

Dear Ms. Cisneros:

The Alamo Area Council of Governments/Bexar Area Agency on Aging (AACOGBAAA) will start the first year of a new three-year planning cycle in October and plans to issue an FY 2004 Service Delivery Agreement to the City of San Antonio for nutrition and transportation. The terms of this agreement shall be for the period of October 1,2003 through September 30, 2004 and shall be incorporated as an integral part of the complete contract for service delivery between the AACOGBAAA and the City of San Antonio. Proposed allocations for the provisional contracts are based upon the FY 2003 planning figures from the Texas Department on Aging (TDoA) at the most recently negotiated unit rates and projected decreases in FY 2004 Federal and State funding. For the City of San Antonio, provisional allocations to be recommended to the AACOG Board of Directors will amount to a total of \$1,477,199 for nutrition services, and \$275,250 for transportation. The City of San Antonio is also being recommended to the AACOG board as a subcontractor for home-delivered meals. The provisional amount of this contract is still under negotiation, but will be finalized in September 2003. The FY 2004 contracts will be based upon actual funds received through Notice of Funds Available **from** TDoA and may differ from these provisional amounts.
