SUMMARY & RECOMMENDATION:

This ordinance authorizes the Purchasing & General Services Department to accept the bid submitted by Commercial Data Systems utilizing the Texas Building and Procurement Commission's Texas Multiple Award Schedule (TXMAS) contract to provide the Police and Information Technology Services Departments with storage area network hardware and software for the public safety integrated technology project. Staff recommends approval of this ordinance.

BACKGROUND INFORMATION:

On February 13, 2003, ordinance no. 97211 was approved allocating funds for computer hardware and software from the General Obligation Bonds – Public Safety Integrated Technology System. This hardware and software will provide the electronic data storage capacity needed for recording all crime report data submitted by the Direct Entry Field Reporting System for a period of up to three years. All crime report data, consisting of typed reports, diagrams, photographs, recordings and witness statements, will be accessible online from any police department personal computer including vehicle-mounted laptop computers. These reports, generated from vehicle-mounted laptop computers and desktop computers will automatically be stored in the computer hardware known as storage area network or SAN system. Once the field officer reports are stored and certified, they will be immediately available for investigative follow-up as well as available for immediate sale to the citizenry at designated locations and via the internet.

POLICY ANALYSIS:

This contract will provide the City of San Antonio Police Department with storage area network hardware and software necessary to electronically store all crime report data. The software is necessary to store, manage and retrieve data stored on the storage area network. The hardware will provide the foundation needed to perform searches into the crime report database from any police department computer. The hardware acquired also provides for a redundant backup should a malfunction occur. The system also comes with a standard one-year manufacturer's warranty.

This purchase is made from Commercial Data Systems utilizing the Texas Building and Procurement Commission's TXMAS program on contract number TXMAS-3-70050. The purchase is being made in accordance with the State of Texas Cooperative Purchasing Agreement adopted by the City of San Antonio Resolution No. 91-39-53.
