Applicant: George Rapier

Zoning Request: "C-1" and "C-3" "NCD-2" Commercial and General Commercial

Neighborhood Conservation District to "R-6" "NCD-2" Residential

Single Family Neighborhood Conservation District.

<u>George Rapier</u>, owner, stated he is requesting this change in zoning to convert the existing office structure to a single-family dwelling.

Staff stated there were 22 notices mailed out to the surrounding property owners, 2 returned in opposition and 3 returned in favor and the Alta Vista Neighborhood Association is in favor.
