Andy Guerrero, 3134 Renker, representing the owner, stated they would like to amend their request to "R-5". He stated they are proposing to develop a single-family subdivision of 219 lots on the subject property.

OPPOSE

<u>James McDee</u>, 5411 Galacino, stated he is concerned with the drainage problems in this area. He is concerned that there would be an excessive amount of run off to his property, which would make it difficult to develop on his property. He would like to request the run off be directed away from his property and also an increase on the setbacks.

REBUTTAL

Andy Guerrero, 3134 Renker, stated as part of the development, he has been working with city staff to relief the drainage issue of this project, which he feels has already been addressed. He stated they are willing to provide 5 feet of existing "C-3" property abutting his property and they would also provide an 8-foot fence.

Staff stated there were 21 notices mailed out to the surrounding property owners, 7 returned in opposition and 4 returned in favor.

Andy Guerrero, 3134 Renker, representing the applicant, stated they are proposing to develop a single-family subdivision on the subject property. He stated they have met with staff to discuss this development and have agreed to a 20-foot drainage interceptor right of way and they would like to amend their request to "R-4" on 6.375 acres of the property and "R-5" on the remaining 32.605 acres. He stated he feels this would relief Mr. McNew's concerns.

OPPOSE

<u>James McNew</u>, 5411 Galacino, stated he is concern on how this may affect his setbacks. He also expressed concerns with who would maintain the right of way.

Staff stated there were 21 notices mailed out to the surrounding property owners, 7 returned in opposition and 5 returned in favor.

COMMISSION ACTION
