# SUMMARY AND RECOMMENDATION

This ordinance authorizes Community Development Block Grant (CDBG) funds in the amount of \$29,475 for fee simple title to certain privately owned real property and other miscellaneous expenses associated with the Evergreen Court - Evergreen Street to N. St. Mary's project and the Evergreen Street - McCullough Avenue to E. Euclid Avenue project, both 27th Year Community Development Block Grant (CDBG) authorized projects, located in Council District 1. This ordinance authorizes City staff to acquire these properties at fair market value by negotiation or condemnation, if necessary.

Staff recommends the approval of this ordinance.

# **BACKGROUND INFORMATION**

# Evergreen Court – Evergreen Street to N. St. Mary's

There are two parcels to be acquired in this two parcel project. Advertisement is scheduled for November 2003, with construction to start in January 2004, and be completed in December 2004. The scope of this project includes the reconstruction of Evergreen Court, from Evergreen Street to N. St. Mary's, to a street width of 30-feet (two lanes), including curbs, sidewalks, driveway approaches, and necessary drainage.

# Evergreen Street – McCullough Ave. to E. Euclid Ave.

There are four parcels to be acquired in this four parcel project. Advertisement is scheduled for November 2003, with construction to start in January 2004, and be completed in December 2004. The scope of this project includes the reconstruction of Evergreen Street, from McCullough Ave. to E. Euclid Ave., to a street width of 30-feet (two lanes), including curbs, sidewalks, driveway approaches, and necessary drainage.

# **POLICY ANALYSIS:**

This ordinance will streamline the process for acquiring right of way for this project and the payment of the miscellaneous expenses associated with this project.

This is a one-time capital expenditure within budget and included in the FY04-FY09 Capital Improvement Program Budget. Funds in the amount of \$17,950 are available from Community Development Block Grant (CDBG) funds.
