SUMMARY AND RECOMMENDATIONS

This ordinance amends a professional service contract and authorizes an additional \$64,935.00 payable to HDR Engineering, Inc., a non-MBE firm, for engineering expenses in connection with the James Park Development and Holbrook Road Improvements project, a 1994 and 1999 Drainage Improvement Bond funded project located in Council District 2.

Staff recommends approval of this ordinance.

BACKGROUND INFORMATION

This ordinance authorizes compensation to HDR Engineering, Inc. for additional engineering services to include Preliminary Phase B and Final Design Plans, quantity take-offs and cost estimates, design surveys and construction staking. HDR Engineering, Inc. proposes to complete the work within 105 calendar days.

This professional services contract with W.E. Simpson Company, Inc. was originally approved by Ordinance No. 82402 on June 22, 1995 and initially authorized \$124,000.00 for services related to this project. Subsequently, the W.E. Simpson Company, Inc. has been acquired by HDR Engineering, Inc.

This project is currently under design, is scheduled for start of construction in April 2004 and to be completed in October 2004.

POLICY ANALYSIS

Approval of this ordinance will be a continuation of City Council policy to complete previously approved 1994 and 1999 Drainage Improvement Bond funded projects.

FISCAL IMPACT

This is a one-time capital improvement expenditure and authorized in the FY 04-09 Capital Improvement Budget. Funds in the amount of \$64,935.00 are available from 1994 Drainage Improvement Bonds and are authorized payable to HDR Engineering, Inc.

COORDINATION

This request for ordinance has been coordinated with the Office of Management and Budget and the Finance Department.

Dear Mr. Gutierrez:

Thank you for the opportunity to prepare and present the scope of work for the above project. The following is the scope for both Phase B and Design Phase according to the City's letter dated July 31, 2003.

Drainage Improvements

- Install 5 5' x 2' box culverts (225 LF total) to convey flow under Holbrook Road near Rittiman Road.
- Beginning at the west end of Parkwood Drive at 4204 Hillman, construct a concrete drop channel, install 2 5' x 2' box culverts under Holbrook Road, and grade a new channel to Salado Creek.
- Correct the alignment of an existing concrete apron, install new energy dissipaters, and construct a new 300' long gabion mat lined channel abutting the Rittiman West Business Park parking lot.

Based on the above items the proposed scope of work for Phase B is as follows:

1) General

- a) Attend Phase B Review Meetings.
- b) Attend Drainage Department review meeting
- c) Develop Final Drainage Report

2) Drainage

- a) DA1-DA3 Prepare draft drainage report.
- b) DA1 Holbrook Road and Rittiman Road
 - i) Develop demolition plan sheet.
 - ii) Develop a plan and profile sheet for the proposed culverts and outfall channel with grading plan.
 - iii) Develop detail sheet.
- c) DA2 Parkwood Drive at Hillman Drive
 - i) Develop demolition plan sheet.
 - ii) Develop a plan and profile sheet for the proposed concrete drop channel, culverts, and outfall channel with grading plan.
 - iii) Develop detail sheet.
- d) DA3 Rittiman West Business Park
 - i) Develop demolition plan sheet.

- ii) Develop a plan and profile sheet for the proposed concrete apron and gabion mat channel and include grading plan.
- iii) Develop detail sheet.
- iv) Evaluate temporary and permanent easement requirements for DA-3.
- e) Utility coordination
- f) Calculate Quantities
- g) Develop probable estimate of construction cost utilizing City average unit bid
- h) Deliverables (17 copies of plans, 5copies of drainage report, 5 copies of cost estimate)

3) Survey

- a) Horizontal Control
 - i) Local assumed control points will be used at DA1 and DA3. The control points will not be tied to a known datum.
 - ii) The City of San Antonio will provide an electronic copy of the survey information recently gathered a DA2 included control point descriptions. Additional survey at this location will be tied to TBM's set by CoSA personnel.

b) ROW

- i) Research right-of-way maps, subdivision plats and deeds along 3 drainage areas.
- ii) Compute recorded right-of-way data.
- iii) Recover and locate existing monuments along 3 drainage areas.
- iv) Provide apparent ROW and parcel lines, including lot numbers, addresses, and legal descriptions.
- c) Topography Of Three Drainage Areas:
 - i) -Area DA1 at Rittiman Road and Holbrook Road (±Sta. 46+50 to ±Sta. 47+50) extending west 150 ft to the bank of Salado Creek and east 50 ft from the edge of pavement.
 - ii) -Area DA2 between Hillman Drive, through 4204 Parkwood Drive and crossing Holbrook Road (±Sta. 46+50 to ±Sta. 66+00) extending west 150 ft to the bank of Salado Creek.
 - iii) -Area DA3 beginning at Holbrook Road (± Sta. 78+00) extending eastward ± 200' along the centerline of an 80' wide drainage right-of-way, then southward ± 700' through a 50' wide proposed drainage easement abutting the Rittiman West Business Park parking lot.
 - iv) Utility coordination for 3 drainage areas
- d) Construction Staking for DA1, DA2, & DA3
 - i) Provide construction offset hubs with existing elevation and design station to HDR Engineering, Inc. for cut sheets.
 - ii) The staking will be based on the design plans and staked one time only.
 - iii) Additional staking or restaking will be charged by the hour.

4) City will provide the following information:

- a) Plat maps for project area
- b) Existing easement within the project area
- c) Hydrology and Hydraulics for Salado Creek, if different from current information developed by HDR.

The proposed scope of work for the Design Phase is as follows:

1) Drainage

- a) Adjust design based on comments from Phase B.
- b) DA1-DA3 Finalize drainage area maps, update 3 drainage area hydrologic calculations, complete detailed hydraulic design, and prepare final drainage report.
- c) Incorporate necessary CoSA standards in plans
- d) Calculate and check quantities
- e) Modify final drawings and sign and seal
- f) Prepare specifications and final cost estimate.
- g) Submit plans and specifications for one day review
- h) Attend Design Phase meeting and coordination meetings
- i) Deliverables (17 copies of plans, 5 copies of report, 5 copies of cost estimate, 1 copy of mylars)

The scope of work above will not include the following:

- a) Advance flood warning (done by others).
- b) Obtaining Permits
- c) Development of new hydrology and hydraulics for Salado Creek.
- d) Development of easement documents.
- e) Attendance to public meetings.
- f) Recovering permanent control points due to actions beyond our control
- g) Boundary surveys or parcel maps
- h) Surveying utility potholes—(measure downs to be provided by utilities off natural ground)
- i) Bid phase Services.
- i) Any work not specifically mentioned above.

The fee for the scope of work as outlined above is as follows:


