## **ZONING CASE NO. Z2003169** – October 7, 2003

Applicant: Hixon Properties Incorporated

Zoning Request: "I-1" General Industrial District to "C-3" Commercial District.

Zek Kennedy, 115 E. Commerce, applicant, stated they are requesting this change in zoning to allow new retail development and modifications to the existing retail building. He stated they are proposing to develop a Walgreen's and Hotel on the subject property. He has agreed to amend their original request to "C-2" zoning.

Staff stated there were 13 notices mailed out to the surrounding property owners, 0 returned in opposition and 2 returned in favor and no response from Downtown Neighborhood Association.

Everyone present, for and against having been heard and the results of the written notices having been received, the Chairman declared the public hearing closed.
