## **ZONING CASE NO. Z2003183** – October 7, 2003

Applicant: City of San Antonio

Zoning Request: To designate "HS" Historic Significance.

Ann McGlone, Historic Preservation Officer, stated this house was presented to the Historic and Design Review Commission on August 6, 2003 and was recommended for approval of Historic Significant. She further stated this house is within the Mahncke Park boundaries and the Mahncke Park Neighborhood Association is in support of this request.

#### **FAVOR**

Greg Gray, 130 Davis Court, stated he is in support of this request. He stated this structure has the characteristics of classic craftsman's homes. He stated the surrounding structures were built around the 1920's. He further stated he feels this structure qualifies for a finding of historic landmark.

<u>Isabel Garcia</u>, 413 Queen Ann Court, stated she has worked on restoration of historic structures and feels this would qualify for historic significance. She strongly supports this zoning request. She stated the surrounding homes in this area were constructed in the 1920's and she would like to keep the historic appearance.

<u>Francille Radmann</u>, 310 Elmhurst, stated she feels this structure meets the historic criteria and is in full support of this request. She stated she would like to keep the historic character of the neighborhood.

<u>Elisa Phelps</u>, 130 Davis Court, stated she purchased a home in Mahncke Park specifically for its historic integrity and its residential character. She stated Davis Street consists of approximately 20 homes each of which contributes to the character of the neighborhood. She feels the lots of any one structure would have a sufficient effect on the neighborhood. Therefore, she is requesting this structure be designated historic.

#### **OPPOSE**

<u>Ken Bently</u>, stated he is in opposition of this request. He stated the structure needs major repairs and feels there is no historic significance in this structure. He further stated this structure is an eyesore and he supports Mr. Perez's proposal of demolishing the structure and constructing a retail center.

#### REBUTTAL

Ann McGlone, stated these structures are important to the neighborhood. She further stated demolition of these structures would be a significant loss to the neighborhood.

A. R. Perez, owner, stated he is not for a historic finding of this structure. He stated he is proposing to demolish the home and construct a retail center on the subject property.

Staff stated there were 22 notices mailed out to the surrounding property owners, 3 returned in opposition and 1 returned in favor and Mahncke Park Neighborhood Association is in favor.

Everyone present, for and against having been heard and the results of the written notices having been received, the Chairman declared the public hearing closed.

#### **COMMISSION ACTION**

The motion was made by Commissioner McAden and seconded by Commissioner Grau to recommend denial.
