Ken Brown, 111 Soledad, representing the applicant, stated they are requesting this change in zoning to allow an automobile dealership on the subject property. He stated this tract lies within the corridor district and they are in compliance, which requires setbacks, buffering and landscaping. He further stated they agree to an "NA" designation.

Staff stated there were 6 notices mailed out to the surrounding property owners, 0 returned in opposition and 3 returned in favor.
