#### SUMMARY AND RECOMMENDATION

This ordinance authorizes Community Development Block Grant (CDBG) funds in the amount of \$9,613 for fee simple title to three (3) parcels of privately owned real property and other miscellaneous expenses associated with Huron - Fitch to Southcross, a Community Development Block Grant (CDBG) authorized project located in Council District 4.

Staff recommends the approval of this ordinance.

#### **BACKGROUND INFORMATION**

There are three parcels to be acquired in this three parcel project. Advertisement is scheduled for December 2003, with construction to start in April 2004, and be completed in September 2004. The scope of this project includes the reconstruction of Huron Street, from Fitch to Southcross providing for a typical street section with sidewalks, curbs, and driveway approaches.

#### **POLICY ANALYSIS:**

This ordinance will streamline the process for acquiring right of way for this project and the payment of the miscellaneous expenses associated with this project.

# FISCAL IMPACT

This is a one-time capital improvement expenditure within budget and included in the FY04-FY09 Capital Improvement Program Budget. Funds in the amount of \$9,613 are available from Community Development Block Grant (CDBG) funds.
