CHANGE FROM THE TEXAS DEPARTMENT OF HEALTH FOR THE

SEXUALLY TRANSMITTED DISEASE STAFF SUPPORT PROGRAM

SUMMARY AND RECOMMENDATIONS

This ordinance authorizes the City Manager to accept and execute a contract change from the Texas Department of Health (TDH) providing an additional \$12,708.00 for the ongoing Sexually Transmitted Disease (STD) Staff Support Program in the San Antonio Metropolitan Health District (SAMHD) for the period January 1, 2003 through December 31, 2003. This ordinance also revises the program budget and amends the personnel complement.

Staff recommends approval.

BACKGROUND INFORMATION

TDH provides annual assistance to the City to support core public health activities provided by the SAMHD. TDH has forwarded Contract Change Notice No. 13 as an amendment to the TDH contract previously accepted through an ordinance passed and approved on February 6, 2003. This amendment revises the program budget of the STD Staff Support Program of the SAMHD. The STD Staff Support Program consists of personnel in the STD Clinic who conduct counseling to control and prevent the spread of sexually transmitted diseases, including HIV/AIDS and viral hepatitis.

In an ordinance passed and approved on August 14, 2003 TDH issued a contract amendment that reduced the STD Staff Support Program budget by \$23,189.00 due to state fiscal constraints. This amendment reduced the personnel complement of the STD Staff Support Program by one position (vacant at the time), the Health Program Supervisor. Now TDH has offered additional funding support and approved replacing this position with a Health Program Specialist, a non-supervisory position. This restores the personnel complement to six (6) positions (See Attachment I), the same number of personnel as supported in last year's grant.

POLICY ANALYSIS

Acceptance of this grant from TDH will continue the long-standing practice of utilizing Federal and State aid to support the local public health programs of the City.

FISCAL IMPACT

This TDH contract amendment provides \$12,708.00 for the STD Staff Support Program in the SAMHD and brings the total budget of this activity to \$224,801.00. Acceptance of this contract change will place no demands on the City General Fund.

COORDINATION

The City Attorney's Office and the Office of Management and Budget, Risk Management Division, have reviewed the contract with TDH. The Finance Department has approved the proposed program budget.

SUPPLEMENTARY COMMENTS

Provisions of the Ethics Ordinance do not apply.
