# **SUMMARY AND RECOMMENDATIONS**

This ordinance authorizes funds in the amount of \$32,415.50 payable to Bracewell & Patterson, L.L.P. for legal services in connection with the Ashley Road - Bascum to S. Flores project (\$496.95), Bitters Road - West Avenue to Heimer MPO project (\$72.20), Cherry Street Drainage Project #15B Phase II (\$2,000), Escalon Street #1008 Drainage project (\$123.30), Hi-Lions Drainage #80, Phases III & V project (\$72), Hildebrand Avenue from IH10 to Breeden MPO project (\$23,401.55), Western Avenue Drainage #74 III-A project (\$3,424.10), Wurzbach Road at I.H. 10 and Ironside Intersections project (\$18), Wurzbach Parkway project (\$2,753.40), and the Fay Phase I Community Development Block Grant (CDBG) project (\$54). These projects are located in various City Council Districts and are funded from General Obligations of the City and Community Development Block Grant (CDBG) funds.

Staff recommends the approval of this ordinance.

# **BACKGROUND INFORMATION**

The invoices for these legal services have been reviewed for accuracy by the City Attorney's Office who recommends payment as requested.

Ashley Road from Bascum Blvd. to South Flores – There are 58 signed instruments in the 60 parcel project. Two parcels have been submitted to the City Attorney's Office for condemnation proceedings. Construction on this project is complete.

Bitters Road from West Avenue to Heimer (MPO) – There are five signed instruments and five condemned parcels in the 10-parcel project. This project is currently under construction and scheduled to be completed in November 2004. The scope of this project includes the widening of the existing roadway to seven lanes, adding left and right turn lanes at U.S. 281 to facilitate traffic through the intersection of U.S. 281, and upgrade traffic signalization. This project will also include the construction of six-foot sidewalks at the curb.

Cherry Street Drainage #15B Phase II – Construction on this project is complete. The City has a Right of Entry Agreement on the parcel currently in condemnation.

Escalon Street #1008 Drainage – All of the necessary parcels have been acquired in this 10-parcel project. Construction on this project is complete.

Hi-Lions Drainage Project #80, Phases III and V — There are 68 signed instruments in the 70-parcel project. The two remaining parcels are in negotiations. Construction on this project is complete. The scope of this project provides for the reconstruction of the streets and drainage in the area bounded by Clark, Vanderbilt, Amanda, and Rigsby. Dasa Leo, Wendy and Shawn Marie are an additive alternate to the project. Project includes two-lane street sections, four-foot sidewalks, curbs, driveway approaches and underground storm drainage. Gas, water, and sanitary sewer mains and laterals will be replaced. It also includes four-foot sidewalks, curbs, driveway approaches, and underground storm drainage.

Hildebrand Avenue from IH10 to Breeden (MPO) – There are 23 signed instruments and three condemned parcels in the 26-parcel project. Construction on this project is complete.

Western Avenue Drainage Project #74, Phase III A – There are 17 signed instruments and eight condemned parcels in the 25-parcel project. This project is currently under construction and is scheduled to be completed in December 2003. The scope of this project includes the construction of a concrete drainage channel through Northern Boulevard at the existing low water crossing, which will result in the permanent closure of Northern Boulevard. A cul-de-sac will be built on Northern Boulevard at the west side of the proposed channel and guardrail will be installed on the east side of the proposed channel.

Wurzbach Road at I.H. 10 and Ironside Intersection (MPO) - All of the necessary parcels have been acquired in this 12-parcel project. Advertisement is scheduled for December 2003 by the Texas Department of Transportation, with construction to begin in February 2004, and scheduled to be completed in July 2005. The scope of work for Wurzbach Road at I.H. 10 will widen the existing 30-foot roadway to 56 feet to lengthen the left turn lanes from 46 feet to 79 feet. The scope of work for Wurzbach at Ironside will widen the existing two-lane northbound approaches to 36 feet for a right turn lane.

Wurzbach Parkway (MPO) Phase V – Phase V of this project is currently funded for design only. The scope of this project includes the construction of a four-lane divided roadway and limited access from Northwest Military Highway to Blanco Road and then continuing from Blanco Road to U.S. 281.

Fay Phase I (CDBG) - There are nine signed instruments and one condemned parcel in the 10-parcel project. This project has completed construction. The scope of this project provided a 27-foot wide, two-lane typical roadway with underground storm water drainage. This project reconstructed Fay from Quintana to the midpoint between Crittendon and Creighton, and Crittendon from Fay to Southcross, and includes four-foot sidewalks, curbs, and driveway approaches.

# **POLICY ANALYSIS**

Approval of this ordinance for payment of legal services is necessary to complete the real estate transactions on the acquisition of the properties in these projects.

# **FISCAL IMPACT**

# Ashley Road – Bascum to S. Flores

This is a one-time capital improvement expenditure within budget and is not included in the FY04-FY09 Capital Improvement Program Budget. Funds in the amount of \$496.95 are available from 1987 General Obligation Street Improvement Bonds.

#### Bitters Road - West Avenue to Heimer MPO

This is a one-time capital improvement expenditure within budget and is included in the FY04-FY09 Capital Improvement Program Budget. Funds in the amount of \$72.20 are available from 2000A Issued Certificates of Obligation.

# Cherry Street Drainage #15B Phase II

This is a one-time capital improvement expenditure within budget and is not included in the FY04-FY09 Capital Improvement Program Budget. Funds in the amount of \$2,000 are available from 1994 General Obligation Drainage Improvement Bonds.

# **Escalon Street Drainage Project #1008**

This is a one-time capital improvement expenditure within budget and is not included in the FY04-FY09 Capital Improvement Program Budget. Funds in the amount of \$123.30 are available from 1994 General Obligation Drainage Improvement Bonds.

# Hi-Lions Drainage #80, Phase III & V

This is a one-time capital improvement expenditure within budget and is not included in the FY04-FY09 Capital Improvement Program Budget. Funds in the amount of \$72 are available from 1987 General Obligation Drainage Improvement Bonds.

# Hildebrand Avenue from I.H. 10 to Breeden (MPO)

This is a one-time capital improvement expenditure within budget and is not included in the FY04-FY09 Capital Improvement Program Budget. Funds in the amount of \$23,401.55 are available from 2002 Certificates of Obligation.

# Western Avenue Drainage Project #74, Phase III A

This is a one-time capital improvement expenditure within budget and is included in the FY04-FY09 Capital Improvement Program Budget. Funds in the amount of \$3,424.10 are available from 1985 General Obligation Drainage Improvement Bonds.

# Wurzbach at I.H. 10 and Ironside Intersections (MPO)

This is a one-time capital improvement expenditure within budget and is not included in the FY04-FY09 Capital Improvement Program Budget. Funds in the amount of \$18 are available from 1996 Certificates of Obligation.

# Wurzbach Parkway Phase V

This is a one-time capital improvement expenditure within budget and is included in the FY04-FY09 Capital Improvement Program Budget. Funds in the amount of \$2,753.40 are available from 2002 Certificates of Obligation.

#### Fay Phase I CDBG

This is a one-time capital improvement expenditure within budget and included in the FY04-FY09 Capital Improvement Program Budget. Funds in the amount of \$54 are available from Community Development Block Grant funds.
