RATIFYING THE SUBMISSION OF GRANT APPLICATIONS AND AUTHORIZING THE ACCEPTANCE OF A GRANT AWARD AND EXECUTION OF CONTRACTS FOR \$39,176 FROM THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) TO FUND A NEW PROGRAM TO

PROVIDE PREDATORY LENDING EDUCATION AND PREVENTION

SUMMARY AND RECOMMENDATIONS

- A. This ordinance ratifies the submission of a grant application to the U.S. Department of Housing and Urban Development (HUD). This ordinance also authorizes the acceptance of the grant funding, when awarded, and the subsequent execution of a contract in an amount up to \$39,176 from HUD by the Fair Housing Program for the period October 1, 2003 through September 30, 2004 to provide predatory lending education and prevention services, and approves a budget and personnel complement.
- B. This ordinance ratifies the submission of a grant application to the U.S. Department of Housing and Urban Development (HUD). This ordinance also authorizes the acceptance of the continuation grant funding, when awarded, and the subsequent execution of a contract in an amount up to \$76,937 between HUD and the City of San Antonio's Housing Counseling Program for the period October 1, 2003 to September 30, 2004 to provide fair housing education and counseling services, and approves a budget and personnel complement.

Staff recommends approval of these ordinances.

BACKGROUND INFORMATION

The U.S. Department of Housing and Urban Development (HUD) requires local compliance with the Fair Housing Act (Public Law 90-824), as amended, and Executive Order 12259, to further fair housing. In its annual application for Community Development Block Grant (CDBG) entitlement funds, the City must certify that it will continue to implement necessary actions to increase and enhance housing opportunities.

The Fair Housing Program consists of two sections, Fair Housing and Housing Counseling, funded from different grants and integrated to provide comprehensive housing services. The City's Fair Housing Program investigates and mediates tenant-landlord complaints, monitors housing

discrimination practices, and encourages voluntary compliance with the city, state, and federal fair housing laws through education and outreach. The Fair Housing Program has been engaged in housing counseling since June of 1972, offering both fair housing and comprehensive housing counseling services to the residents of Bexar County and surrounding areas. As a Housing and Urban Development (HUD) Certified Housing Counseling Agency since 1979, the Housing Counseling Program has continued to offer housing services to potential homebuyers and renters of HUD insured, HUD assisted, and conventional housing to the residents of San Antonio and Bexar County.

POLICY ANALYSIS

Anti-Predatory Lending Program

This ordinance accepts grant funds to implement a new initiative to provide anti-predatory lending services through education and public awareness. Predatory lending occurs when there is a financial agreement for a home purchase, refinance, or improvement where the lender utilizes overly aggressive, deceptive and/or fraudulent sales and financing tactics to take unfair advantage of unsophisticated borrowers.

For the period October 1, 2003 through September 30, 2004, the Fair Housing Program will provide direct services to approximately 1,236 families in San Antonio and Bexar County (Attachment A). The services will include: (1) group workshops on predatory lending issues; (2) one-on-one counseling to predatory lending victims; (3) outreach and educational presentations on identifying and avoiding predatory lending, including distribution of materials; (4) financial literacy classes to area high school students, to include information about the City's IDA program; and (5) education for working families on prime and sub-prime loans. One additional Caseworker II will be added for this program.

Housing Counseling Program

The Housing Counseling section will provide direct services to approximately 2,540 families in San Antonio and Bexar County during the period October 1, 2003 through September 30, 2004 (Attachment B). The services will include: (1) counseling services to default homeowners and to reverse mortgage applicants; (2) educating tenants and landlords of their rights; (3) community education presentations; (4) pre- and post- purchase and/or occupancy counseling; (5) homebuyer education; (6) delinquent renter counseling; (7) tenant/landlord mediation; and (8) public awareness of predatory lending practices. Two additional Caseworker II's will be added for this program.

These ordinances continue existing City policy adopted by City Council to utilize grant funds to provide comprehensive housing services to the residents of San Antonio and Bexar County. It is a continuation of the Department's efforts to provide leadership, maximize resources, and improve the quality of life within our community. These funds will enhance the Department's goals of family strengthening and human development.

FISCAL IMPACT

- A. This a new grant will provide the Fair Housing Program with \$39,176 to support anti-predatory lending education and prevention services. There is no General Fund commitment.
- B. This continuation grant will provide the Department of Community Initiatives with \$76,937 for comprehensive housing counseling services over a one year period? It will be for a one-year period beginning October 1, 2003 and ending September 30, 2004. This grant represents a 60% increase in funding by HUD from the previous grant award. Funding for the program has averaged \$30,000.00 for each twelve-month period for the past two years. There is no General Fund commitment.

COORDINATION

Coordination has occurred with the City Attorney's Office, the Housing and Community Development Department, the Finance Department, the Office of Management and Budget and the Neighborhood Action Department (NAD). DCI and NAD coordinate services and referrals in order to prevent any duplication of services: NAD serves only first time homebuyers, whereas DCI investigates and resolves tenant and landlord complaints and provides counseling to default mortgage clients, reverse mortgage applicants and predatory lending victims.
