SUMMARY AND RECOMMENDATIONS

The purpose of this presentation is to provide City Council with a holistic overview of the current status of transportation in San Antonio; an in depth analysis of where our city is headed with the current rate of growth; major transportation partners; methods for managing roadway congestion and safety issues; and transportation funding issues.

There is no formal action requested.

BACKGROUND

Traffic congestion has steadily increased in San Antonio due to our city's growth rate. In 2000, San Antonio experienced the greatest percentage increase in congestion of the 75 largest U.S. cities. In 2001, San Antonio experienced the second highest percentage increase in the country. Given the current trend, San Antonio must continue to work together with agencies, committees and memberships to seek methods to solve congestion problems in a holistic manner. partner agencies include the Alamo Area Council of Governments, Area Chambers of Commerce, Bexar County, Metropolitan Planning Organization (MPO), San Antonio Mobility Coalition, Texas Department of Transportation, and VIA Metropolitan Transit Authority. It is the MPO that coordinates the efforts of the partner agencies. The MPO's mission is to provide comprehensive, coordinated and continuous ("3C") transportation planning for the safe and efficient movement of people and goods consistent with the region's overall economic, social and environmental goals. The above mentioned partners must work together a concerted effort to benefit all users of the entire transportation network. This network is comprised of highways, primary and secondary arterials, collectors, and local residential streets.

Traditional transportation funding sources will be insufficient to solve San Antonio's existing and future transportation congestion problems. It is critical that all the area's transportation partners work together to identify new transportation funding tools and new methods of managing traffic throughout the community.

- Maximize transportation resources.
