SUMMARY AND RECOMMENDATIONS

This Ordinance will declare as surplus and authorize the sale of four (4) tracts of City-owned real properties legally described as NCB 6567, Block 5, Lot 6 to Erasmo Diaz for \$7,694.00, NCB 7264, Block 17, Lot E 63 FT of W 68 FT of 20 to Victor Aleman for \$10,000.00, NCB 7265, Block 24, Lot E 60 FT of W 65 FT of 5 to Victor Aleman for \$10,000.00 and NCB 11211 of E 603.8 FT of TR 2 to Southway Ford, Inc. for \$11,000.00 as advertised and offered through the sealed bid process, for the total the consideration of \$38,694.00.

Staff recommends approval of this Ordinance.

BACKGROUND INFORMATION

The Department of Asset Management is requesting to declare as surplus and sell four (4) tracts of City-owned real properties legally described as NCB 6567, Block 5, Lot 6 in City Council District No. 5, NCB 7264, Block 17, Lot E 63 FT of W 68 FT of 20 in City Council District No. 1, NCB 7265, Block 24, Lot E 60 FT of W 65 FT of 5 in City Council District No. 1 and NCB 11211 of E 603.8 FT of TR 2 in City Council District No. 4, as shown on Exhibit "A". These properties have been offered through a sealed bid process on November 14, 2003 as outlined in Chapter 272 of the Local Government Code. Staff received and accepted bids on all four (4) City-owned properties on December 1, 2003. These properties will be conveyed by a Deed Without Warranty.

POLICY ANALYSIS

This action is consistent with the City Code and Ordinances, which require City Council approval for the disposition of any surplus City-owned real property.

FISCAL IMPACT

The City will sell these surplus City-owned real properties for the total consideration of \$38,694.00.

COORDINATION

In compliance with City procedures, this request has been canvassed through interested City departments, public utilities and applicable agencies.

The City of San Antonio's Planning Commission will consider this request at its regular meeting of 1/14/2004 and its finding will be presented to City Council on 1/22/2004.

Executed Discretionary Contracts Disclosure Statements are not required for these transactions.








Map of Property legally described as NCB 6567, Block 5, Lot 6
