SUMMARY AND RECOMMENDATIONS:

This ordinance will approve the parade permit and authorize the temporary closure of certain streets in connection with the St. Patrick's Day Run being held on Saturday, March 13, 2004. The run/walk will assemble and disband at Koehler Pavilion (Brackenridge Park). The route is attached.

Staff recommends approval of this ordinance.

This ordinance is consistent with the City policy requiring an ordinance where closures of public streets are requested.

COORDINATION:



FINANCIAL IMPACT:


