Approval. The subject property has an existing Residential Single-Family structure on it. There is "C-2" zoning abutting the subject property to the northwest. Prior to the 2001 Unified Development Code adoption, those properties were zoned "B-2." That particular zoning allowed multi-family dwellings. In as much, there are several apartments on those properties that were built prior to the current zoning change. The subject property however was zoned "R-6" at that time, and was later changed to "C-2.". The requested zoning is compatible with the development scheme of the area, and will have no adverse impact on nearby properties.
