Staff recommends approval of this ordinance in order to transmit the information to the U.S. Department of Justice.


BACKGROUND INFORMATION

Due to voters' preference, accessibility issues and availability of certain locations, changes in election day polling sites are necessary.


At present, East Central Independent School District (ECISD) is expected to be a participant in the Joint and Special election scheduled for Saturday, May 15, 2004. However, it may be necessary for ECISD to withdraw from the election at a later date based on the outcome of pending litigation.

COORDINATION


