SUMMARY AND RECOMMENDATIONS

This ordinance accepts the proposal and awards a professional service contract in amount not to exceed \$83,884.50 payable to Shannon P. Marquez, dba Jenkins, Austin, Márquez & Associates, a WBE, for professional facilitation services and associated reimbursable expenses for the Ad Hoc Citizen's Water Quality Review Committee.

Staff recommends approval of this ordinance.

BACKGROUND INFORMATION

The Ad Hoc Citizen's Water Quality Review Committee functions under the Quality of Life Committee chaired by Councilman Carroll Schubert and reports directly to Mayor Ed Garza. The Committee, chaired by Councilman Art Hall, is charged with reviewing and making recommendations relating to the adoption and support of additional governmental regulations and other measures required for protection of the quality of water in the Edwards Aquifer. The committee will assess the adequacy of regulation of activities, which have the potential for polluting the Edwards Aquifer, and hydrologically connected surface streams, whether such activities occur on the recharge, transition, or contributing zones of the Aquifer. The committee may request relevant documents and resources from other interested parties including Bexar County, surrounding incorporated cities and surrounding counties and will make recommendations, as needed. Currently, the committee is in the process of reviewing all water quality related ordinances and regulations as they pertain to Texas Commission on Environmental Quality (TCEO), Edwards Aguifer Authority (EAA), San Antonio Water Systems (SAWS), and the City of San Antonio (COSA).

This ordinance authorizes compensation to Shannon P. Marquez, doing business as Jenkins, Austin, Márquez & Associates, for professional facilitation services for the Ad Hoc Citizen's Water Quality Review Committee necessary to facilitating committee meetings; reviewing and evaluating existing studies, models, and data; developing decision criteria and regulatory impact analysis (RIA); facilitating stakeholder negotiations and consensus-building for final recommendations. These tasks are to be completed by August 2004.

This firm was selected through the City's solicitation process, whereby a Request for Qualifications was released and three firms responded with Interest Statements. Ms. Marquez' firm, Jenkins, Austin, Márquez & Associates, was selected by the Public Works Architect and Engineer Selection Committee based on the firm's extensive experience in environmental services, water resource issues and regulatory requirements, as well as previous experience in working with municipalities, government agencies, non-profit organizations, corporations and international institutions.

POLICY ANALYSIS

Approval of this ordinance will be a continuation of City Council policy to maintain water quality standards in the San Antonio metropolitan area and surrounding counties.

FISCAL IMPACT

Funds in the amount of \$83,884.50 are available from the Storm Water Operating Fund and are authorized payable to Shannon P. Marquez, dba Jenkins, Austin, Márquez & Associates as follows:
