Staff Recommendation:

Approval. The Baptist Hospital and other medical buildings are currently legal and nonconforming uses and structures located on the subject property. A medical office complex exists to the north and east of the property, with apartments to the west and parking to the south. The requested zoning change is to have the zoning match the existing use and to further expand the hospital facility. The requested zoning shall allow the hospital to maintain its function and permit the expansion of the facility on the property, in excess of the 5,000 square feet permitted in a "C-1" Light Commercial District. Considering the current location of the hospital and the importance of such emergency facilities to the health and well being of citizens, the rezoning request shall not adversely affect the surrounding community.

<u>Don Ryden</u>, 215 E. Quincy, representing the applicant, stated they are requesting this change in zoning to expand their existing facilities to better serve the community.

Staff stated there were 45 notices mailed out to the surrounding property owners, 3 returned in opposition and 6 returned in favor and no response from Pecan Valley Neighborhood Association.

Everyone present, for and against having been heard and the results of the written notices having been received, the Chairman declared the public hearing closed.
