Approval. The property is surrounded by "C-3" zoning and uses except to the north, which is ranch land and "R-6" zoning. To the rear of the property is a mini-storage facility and to the south is a large garden supply company. The subject property is currently zoned "C-2 NA C" Commercial Nonalcoholic Sales District with conditional use for a Print Shop. The requested zoning is to change the conditional use to a contractor's facility with outside storage. The Outdoor Storage Standards in the Unified Development Code will require appropriate screening and buffering to adjacent properties. The proposed conditional use is consistent with other uses in the immediate area.
