Denial. The request for an "S" does not change the allowable uses in the existing district therefore the request is consistent with the South Central San Antonio Community Plan. Subject property is currently a used car lot. The aforementioned property abuts residential zoning and use to the north, and across Christy Street to the east. There is also residential zoning and use across East Harlan Avenue to the south. Section 35-388 (d)(2) of the Unified Development Code indicates that communication towers shall be spaced 200 feet from all residential zoning districts. The location of the requested zoning change for the proposed communication tower is immediately adjacent to existing residential zoning and use.

Mr. Fred, representing the applicant, stated the purpose of this request is to allow for a communication tower on the subject property to provide better service to their customers. He stated these communications towers are designed to fall in themselves in strong storms. He further stated they would not risk any danger to the adjoining residential homes. He stated he has met with Councilman Segovia to present his proposal.

Staff stated there were 22 notices mailed out to the surrounding property owners, 0 returned in opposition and 1 returned in favor.

Everyone present, for and against having been heard and the results of the written notices having been received, the Chairman declared the public hearing closed.
