I request Council concurrence to direct the Department of Development Services staff to take appropriate steps in bringing forward to the Zoning Commission for their recommendation on May 18th 2004, and to the City Council for final action on May 27th 2004, the rezoning of a tract of land inside KellyUSA (formerly Kelly Air Force Base). This residentially zoned property is occupied by the Roberson Building. The Greater Kelly Development Authority acquired this property for further KellyUSA development.
