<u>Fred Rangel</u>, 6102 Border Trail, representing the applicant, stated they are requesting this change in zoning to allow to develop an 84 unit self service, climate control storage facility on the subject property. He stated they anticipate no exterior changes to the façade of the building however they do intent to remodeling the interior of the building. Staff stated there were 12 notices mailed out to the surrounding property owners, 1 returned in opposition and 1 returned in favor.
