SUMMARY AND RECOMMENDATIONS

This ordinance amends a professional service agreement in the amount of \$36,450 payable to Vickrey & Associates, Inc. for professional engineering services, in connection with the Prue Road Extension: Prue to Huebner project, an authorized 1999-2004 General Obligation Street Improvement Bond and Metropolitan Planning Organization (MPO) funded project located in Council District 8.

Staff recommends approval of this ordinance.

BACKGROUND INFORMATION

This project will provide for the extension of the roadway along a new alignment and will include four lanes and a raised center median. The roadway will connect Huebner and Research and will also include six-foot sidewalks at the curb and necessary drainage improvements. Construction is anticipated to begin December 2006 and to be complete in June 2008.

This ordinance will amend the professional services agreement and authorize funds in the amount of \$36,450 payable to Vickrey & Associates for additional professional services to include the design of median openings and permanent storm water pollution facilities, preparation for these facilities, right of way survey platting and field notes, and street widening to accommodate bicycle lanes. This street is included in the major thoroughfare plan. Changes in the original project scope are also necessary to meet the U.S. Army Corps of Engineers requirements for the reduction of storm water pollutants.

The professional services agreement for Prue Road Extension: Prue to Huebner was originally approved by City Ordinance Number 92482 on September 14, 2000 and authorized \$135,000 for design services. City Ordinance Number 96288, passed and approved on September 5, 2002, authorized additional funding in the amount of \$33,000 to provide for extension of the project limits, scope and design criteria. Ordinance Number 97543, passed and approved on May 1, 2003 authorized additional funding in the amount of \$11,550 and increased the amount of this agreement to \$179,550 to provide for the preparation of right-of-way (ROW) acquisition documents. This ordinance will increase the total authorized for this professional services agreement to \$216,000.

POLICY ANALYSIS

Approval of this ordinance will be a continuation of City Council policy to participate in the development and construction of City selected and approved MPO projects, which are approved annually by City Council.

FISCAL IMPACT

This is a one-time capital improvement expenditure and is included in the FY 04-09 Capital Improvement Program Budget. Funds in the amount of \$36,450 are available from the 1999-2004 General Obligation Street Improvement Bond funds, and are authorized payable to Vickery & Associates, Inc.

COORDINATION

This request for ordinance has been coordinated with the Office of Management and Budget and the Finance Department.



Vickrey & Associates, Inc. is pleased to submit a proposal to provide professional services for the referenced project. The services to be provided are to add median openings, left turn lanes and our returns with pavement stub out for future streets. These changes will be made to the Final Design plans in accordance with our meeting in your offices on October 7, 2003. There will be two additional median openings, and five street stubs for future 30-foot wide streets including curb returns and pavement extending to the right-of-way line. A left turn lane will be added at the Laureate Intersection for a new street stub out.

The scope of services to perform the work is generally outlined as follows:

- Meet with City staff and developers to define project goals
- Evaluate potential locations for the median openings in accordance with the
 project goals, City design requirements, and the location of trees. The trees
 considered will be limited to those field surveyed during the design survey for
 the project and are therefore generally restricted to those located within the
 right-of-way for the street.
- Coordinate length of storage in left turn lanes with CoSA Traffic Engineering.
 Calculate the geometry for the new median openings and curb returns and revise the project base sheet.
- Revise plan sheets to conform to new base sheets. Plans primarily affected will include the roadway plan and profiles, signage and striping, and drainage plan. Calculate elevations for the median curb and curb returns.
- Revise the sheet quantities and summary quantities and the construction cost estimate.
- Implement our Quality Control Program to review the overall quality of the work performed.

We can perform the services for a fixed fee amount of \$11,050. If this is acceptable to you, please indicate by signing below and returning the signed copy to our office.

Attached is the cost estimate you requested at the meeting for the five stub streets. The estimate indicates a cost of \$2,744.42 for each stub, or \$13,722.08 for all five. This excludes any permanent or temporary Right-of-way or easement metes and bounds.

This agreement excludes any revision to the approved schematic plan as currently approved.

Pursuant to your request, Vickrey & Associates, Inc. is pleased to present this proposal to provide professional services on the above referenced project. This proposal supercedes our January 16, 2004 proposal for widening the sidewalks. Work will consist of the revising the plans, quantities and estimate to widen the street one-foot on each side, increasing the pavement width from 64' to 66', in order to provide a bike path along the outside curb on each side of the street. Work is to be done in accordance with your fax layout of February 24, 2004 and includes the following:

- 1. Revise the project base sheets to show the wider street, and evaluate all plan sheets to determine the impact.
- 2. Revise plan and profile sheets to reflect widened street.
- 3. Revise typical sections to reflect widened street section.
- 4. Revise intersection layouts.
- 5. Revise culverts and headwall to extend length of culverts one-foot in each direction, modify channel riprap and extended detention basin weirs, and rerun hydraulic calculations for the culvert.
- 6. Revise storm drain calculations and plan and profile sheets to move curb inlets to new curb location.
- 7. Revise signing and striping per Texas MUTCD to modify lane widths and include bike lane.
- 8. Revise quantities (i.e. earthwork, top soil, sod, curb, base and pavement, culverts, signing and striping) and cost estimate to reflect changes.

We propose to provide the professional services outlined herein for the lump sum fee of \$6,650. A breakdown of man-hours and fee by task is attached. We further propose to complete the work within 15 working days of receipt of your written notice to proceed.

This proposal is based on TxDOT's approval of the lane widths and layout as shown in the fax and as described above, and that no further revisions will be required to the

Dear Mr. Bayer:

Vickrey & Associates, Inc. considers that any work required on subject project to bring it into compliance with the Corps of Engineers 401 Nationwide Permit Program is not part of the scope of work in our contract for the project. We have stated this position at meetings at the City on February 14, 2002 and on May 1, 2003. It is also our understanding that the need for permanent measures to mitigate silt discharge is a relatively new requirement, and it didn't become an issue until well into the project.

In order to develop permanent measures to mitigate silt discharge, it would be necessary to evaluate several alternatives including, but not limited to, vegetative filter strip, filter inserts in curb inlets and stormwater interceptors. A vegetative filter strip may be difficult to adapt to the project as it would require discharging through the curb and would require additional right-of-way. The other alternatives will require some level of maintenance.

In order to evaluate the alternatives, make a recommendation, meet with and reach consensus with City staff, and modify the storm drain plans to accommodate the selected alternative will require an additional effort on our part outside of our original contract.

We can perform the services for a fixed fee amount of \$10,000. If this is acceptable to you, please indicate by signing below and returning the signed copy to our office.
