Approval. These properties were part of an annexation in 2000. It is the policy of the city to rezone annexed property to an appropriate zoning classification. The subject properties are currently zoned R-6. The subject properties include vacant land and one Recreational Vehicle Park. The parcels are located at the intersection of two major thoroughfares. The Recreational Vehicle Park was in existence prior to the 2000 annexation.

The proposed zoning is appropriate given the location and proximity to the commercial node.

City staff represented this case.

<u>Joe Stubblefield</u>, 1218 Euclid, representing the owner, stated they preparing a master plan for the development of the area in the flood plain. He stated with the expansion of 1604 the water in the flood plain would be reduced. This would be a mixed-use development with commercial with hotel units with appropriate parking. The other request would be 24 units of housing, fourplex units with a pavilion in the middle.

Staff stated there were 58 notices mailed out to the surrounding property owners, 5 returned in opposition and 0 returned in favor and Oak Creek Neighborhood Association is in opposition.

Everyone present, for and against having been heard and the results of the written notices having been received, the Chairman declared the public hearing closed.

COMMISSION ACTION

The motion was made by Commissioner Peel and seconded by Commissioner Dutmer to recommend approval of "C-2" on P-14A, "C-2" P-10 and "C-2"C for a recreational vehicle park.
