Consistent. The request for an "S" does not change the allowable uses in the existing zoning district therefore a finding of consistency is recommended.

Denial. Subject property is undeveloped land. The aforementioned property abuts residential zoning and use to the northeast. There is also residential zoning and use across Guadalajara Drive to the north. Section 35-388 (d)(2) of the Unified Development Code indicates that Communication towers shall be spaced 200 feet from all residential zoning districts. The location of the requested zoning change for the proposed communication tower is immediately adjacent to existing residential zoning and use.
