SUMMARY & RECOMMENDATION

This ordinance authorizes the execution of an amendment to the existing concession agreement with HMSHost for Simply Books/Starbucks Coffee location, known as Space 162, San Antonio International Airport, Terminal One. The amendment will provide for the adjustment in the rental commencement date and the square footage of the demised premises.

Staff recommends the approval of this ordinance.

BACKGROUND INFORMATION

Ordinance Number 95351, passed and approved by City Council on February 22, 2002, awarded HMSHost a concession contract for a 1,763 square foot facility in Terminal One. HMSHost (Concessionaire) has operated the location known as Simply Books/Starbucks Coffee since opening on June 11, 2003 and has provided quality customer service and products to the traveling public. This Ordinance will allow the concession agreement to be modified to reflect the reduction in the square footage of the location as a result of post 911 security requirements by the Transportation Security Administration (TSA). In conjunction with the reduction of the square footage, the rental commencement date will be modified to reflect the delays in Concessionaire's completion of the location resulting from the redesign of the premises. The relocation and enlargement of the existing exit lane from the Terminal One concourses and the inclusion of a private search area, as directed by the TSA, reduced the square footage of the Simply Books location from 1,763 square feet to 1,488 square feet and delayed the commencement of construction. The amendment changes the rental commencement date from May 4, 2003 to June 11, 2003.

The Concessionaire has proven to be an outstanding operator in the concession program, generating average sales of \$107,940.00 per month in 2003 and sales levels in excess of \$142,000.00 for the first four months of 2004. As a result, the Concession produced \$79,703.00 in revenue to the City for 2003 and \$51,168.00 for the four months in 2004.

HMSHost operates six (6) locations in the San Antonio International Airport in addition to the Simply Books/Starbucks location and has been a major contributor to the success of the revitalized concession program. HMSHost operates over 200 branch locations in 70% of the nation's largest airports, with 15 Simply Books locations in 14 airports.

POLICY ANALYSIS

This ordinance is consistent with the City Council policy of maintaining a selfsufficient airport by the generation of revenue through the leasing of City owned properties.

FISCAL IMPACT

No financial impact to the City.

COORDINATION

This item has been coordinated with the City Attorney's Office.

Indirect contributions by an individual include, but are not limited to, contributions made by the individual's spouse, whether statutory or common-law. Indirect contributions by an entity include, but are not limited to, contributions made through the officers, owners, attorneys, or registered lobbyists of the entity.
