SUMMARY & RECOMMENDATION

This ordinance authorizes the cancellation of the existing concession agreements of Duty Free of San Antonio-News and Gifts Shops International San Antonio Partnership (DFSA/NGSI - San Antonio) under Ordinance Number 95351, passed and approved by City Council on February 22, 2002.

Staff recommends the approval of this ordinance.

BACKGROUND INFORMATION

Ordinance Number 95351, passed and approved by City Council on February 22, 2002, awarded a concession contract to DFSA/NGSI - San Antonio for the concession spaces 204, 260, 262 and an option for space 238, San Antonio International Airport, Terminal Two. The Concession Agreement for DFSA/NGSI - San Antonio provided for the expansion of the news and gift concession in Terminal Two, with the Concessionaire exercising the option to open Space 238. As a result of decreased enplanements in Terminal Two, opening the location will cause the partnership increased difficulty in generating revenue due to the reduced sales from the three existing DFSA/NGSI locations.

In 2003 the DFSA/NGSI – San Antonio achieved an average of 70% of the sales projections for all locations in Terminal Two.

The cancellation of the agreement will eliminate the current encumbrance on the space and allow for the opening of a second business center in Terminal Two.

POLICY ANALYSIS

This ordinance is consistent with prior policy, as evidenced by the City Council approved Concession Procedures Manual and Policy Statement of January 11, 2001.

FISCAL IMPACT

The financial impact to the City as a result of the cancellation of the DFSA/NGSI- San Antonio lease for space 238, would be the elimination of Minimum Annual Guaranteed rent of \$68,000. The cancellation of the agreement will be mitigated by increase sales generated by the existing DFSA/NGSI San Antonio Partnership locations.

This item has been coordinated with the City Attorney's Office.
