#### **SUMMARY AND RECOMMENDATIONS**

This ordinance authorizes payment in the amount of \$32,000.00 from the Convention and Visitors Facilities Fund to Gould Evans Associates, P.L.L.C. for stand-by consultant architectural services associated with the HemisFair Park Master Plan Project in City Council District 1.

Staff recommends approval of this ordinance.

#### **BACKGROUND INFORMATION**

Work has been completed on the HemisFair Park Area Master Plan. Forty-seven meetings with the general public and stakeholders were held to complete the plan. The Master Plan was presented to City Council and adopted through Ordinance 99009 on March 25, 2004.

The project required professional architectural services to facilitate meetings and to prepare design documents. Originally, this work was going to be divided between two design firms that were selected through Ordinance 97944 on August 7, 2003 and Ordinance 98075 on October 28, 2003, which were Beaty & Partners Architects, Inc. and Gould Evans Architects, P.L.L.C. However, after the work began, Beaty & Partners Architects, Inc. removed itself from the planning process because of a possible conflict. The planning process continued, with all of the consultant work being provided by Gould Evans Architects. Total amount that will be paid to the consultant for this project is \$32,000.00.

## **POLICY ANALYSIS**

The consultant was chosen in accordance with the City's consultant selection procedures and was approved by Ordinance 98075 on October 28, 2003.

## **FISCAL IMPACT**

The amount of \$60,000.00 in Convention and Visitors Facilities Funds were previously approved for the HemisFair Park Master Plan Project.

#### **COORDINATION**

The Office of Management and Budget, Finance Department and Asset Management Department have assisted with this action.

Any Individual or business entity seeking a discretionary contract from the city must disclose in connection with a proposal for a discretionary contract all political contributions totaling one hundred dollars (\$100) or more within the past twenty-four (24) months made directly or indirectly to any current or former member of City Council, any candidate for City Council, or to any political action committee that contributes to City Council elections, by any individual or business entity whose identity must be disclosed under (1), (2) or (3) above. Indirect contributions by an individual include, but are not limited to, contributions made by the Individual's spouse, whether statutory or common-law. Indirect contributions by an entity include, but are not limited to, contributions made through the officers, ewners, attorneys, or registered lobbyists of the entity.
