Zoning Request: "MF-33" Multi-Family District to "C-2" Commercial District.

<u>Charles Edens</u>, 3230 Burnside, representing the applicant, stated they are purpose of this request is for sale of second hand merchandise on the subject property. He further stated the surrounding uses are compatible with this request. He stated he has been in contact with City staff and was advised to amend their request to "NC" C with City Council's approval for resale merchandise. He stated he has been in contact with Ms. Tina Thacker, representative of the Monte Vista Historical Association who is in support of this request.

FAVOR

Marta Pelaez, 7911 Broadway, President of the Battered Women's Shelter, stated they strongly support this request.

<u>Tina Thacker</u>, 120 E. Mulberry, representing Monte Vista Historical Association, stated they are in support of the "NC" C zoning request. She further stated this is compatible with other buildings in the area. She stated the "NC" C would be an appropriate buffer zoning between the "C-2" zoning uses.

Staff stated there were 25 notices mailed out to the surrounding property owners, 0 returned in opposition and 3 returned in favor and Monte Vista Historical Association is in favor of "NC" C for a resale shop.
