Staff Recommendation:

Consistent. C2-P is deemed consistent with land use plan portion of the Southside Initiative Community Plan.

Denial. The Southside Initiative Community Plan designates the land use category for this property as Urban Living. Although consistent with the plan, Section 35-421(e)(3) states that the suitability of the tract for use as presently zoned shall be considered as part of the approval criteria for a zoning amendment. The proposed restaurant is allowed in all commercial districts including NC, C1, C2, and UD. The change in zoning would allow the property to be developed without the development standards promoted by the Southside Initiative Community Plan which include a requirement for the building to be placed near the public right-of-way with the majority of the parking at the back, limiting signs to monument and wall mounted signs, and requiring a larger vegetative buffer (Type E or N, 30 foot) rather than a Type B (15 foot) buffer otherwise required by the UDC along a major arterial. The existing land use is vacant and keeping the zoning UD Urban Development would promote compatibility with adjacent property that is also zoned UD Urban Development which allows a mix of commercial and residential uses.
