CONTRACT WITH THE TEXAS DEPARTMENT OF HEALTH FOR THE AIDS

SURVEILLANCE PROGRAM

#### **SUMMARY AND RECOMMENDATIONS**

This ordinance authorizes the City Manager to accept and execute a change to the contract between the Texas Department of Health (TDH) and the San Antonio Metropolitan Health District which will revise the budget of the ongoing AIDS Surveillance Program in the SAMHD and reduce the total budget ceiling of said program by \$31,409.00 for the period April 1, 2004 through December 31, 2004. This ordinance will also revise the program budget and revise the personnel complement.

Staff recommends approval.

#### **BACKGROUND INFORMATION**

On December 4, 2003 City Council approved a contract with the Texas Department of Health which provides funding to the San Antonio Metropolitan Health District for a number of ongoing programs. Each program is tied to the contract through a contract change notice. As grants are renewed during the year, attachments are added to the contract through contract change notices. The AIDS Surveillance Program, one of the grants supported by this contract, received its annual funding through a contract change notice that the City Council passed on May 6, 2004. Staff in the AIDS Surveillance Program compiles reports from local laboratories and infection control nurses to identify individuals in Bexar County who have contracted AIDS.

Funds for this AIDS program ultimately come from the federal government and are passed through. TDH to local public health departments. TDH made an estimate of the State allocation for the program and based local contracts on this amount. Unfortunately, total monetary support for the program this year was less than anticipated. For this reason TDH has issued a reduction of \$31,409.00 to the program budget. Because of this reduction, the Health Program Supervisor position in the AIDS Surveillance Program is being eliminated. The employee currently in that position is being transferred to

another SAMHD communicable disease project. This will reduce the personnel complement in the program to three (3) positions (See Attachment I).

#### **POLICY ANALYSIS**

Acceptance of this contract change is consistent with contract guidelines. TDH has the authority to adjust grant funding as needed to administer the resources available.

#### **FISCAL IMPACT**

This TDH contract change will reduce the previously approved budget for the ongoing AIDS Surveillance Program in the SAMHD from \$117,712.00 to \$86,303.00. Total support provided under this contract with TDH with all attachments will be reduced to \$1,312,010.00.

Acceptance of this contract change will place no demands on the City General Fund.

#### **COORDINATION**

The City Attorney's Office and the Human Resources Department, Risk Management Division have reviewed the contract with TDH. The Finance Department has approved the proposed program budget.

#### **SUPPLEMENTARY COMMENTS**

Provisions of the Ethics Ordinance do not apply.
