Approval. The request is consistent with the Tobin Hill Neighborhood Plan. The Tobin Hill Neighborhood Plan designates the subject property for commercial use. Furthermore, the property is not located within the Housing Protection Zone designated by the Plan. The Tobin Hill Neighborhood Plan, adopted in 1987, should be considered in evaluating this rezoning request, however a finding of consistency is not required.

A vacant multi-family residential structure exists on the subject property and is surrounded by multi-family and single-family residences with offices and commercial uses. The O-1 Office District is an appropriate transition from the C-3 General Commercial Districts and uses to the east and south and the MF-33 Multi-Family District to the west and south. The O-1 Office District encourages adaptive re-use of the vacant structures within the neighborhood.
