SUMMARY AND RECOMMENDATIONS

This Ordinance authorizes the acceptance and appropriation of two grants from the Texas Commission for the Arts (TCA) to support local agencies funding and the Cultural Collaborative (TCC). The first grant, in the sum of \$37,480, will provide operational and project support for three local arts organizations. The second grant, in the sum of \$2,500, will support TCC marketing and public relations efforts.

Upon approval by the City Council, the Interim City Manager, or his designee, will be authorized to contract with the agencies listed on the attachment, for arts and cultural services.

The Cultural Arts Board and Staff recommend approval of this ordinance.

BACKGROUND

This year, the TCA suspended its Decentralization Grants program that awarded the Office of Cultural Affairs (OCA) an annual non-competitive grant to supplement local art agency funding. The TCA also encouraged eligible cities to apply for funding through their annual competitive process. As a result, OCA submitted a sub-grant application requesting \$40,000 to supplement the Community and Visitor Facilities Funding, and a Core grant application requesting \$35,000 to support the Cultural Collaborative marketing and public relations efforts. On August 31, the TCA announced that San Antonio was awarded a sub-grant of \$37,480 and a Core grant of \$2,500. The TCA sub-grant was applied to FY 2005 art funding process and was included in the proposed final recommendations that the Cultural Arts Board (CAB) approved on September 7, 2004. The Core grant will be utilized to promote the Cultural Collaborative. The organizations recommended for TCA funding in this ordinance are attached.

POLICY ANALYSIS

The TCA grants will continue to augment operational and project support activities funded by the Community and Visitor Facilities Fund, as well as supporting the Cultural Collaborative.

FINANCIAL IMPACT

This ordinance authorizes payment to the attached listing of delegate agencies from the Texas Commission on the Arts' Sub-grant program. There is no impact on the Community and Visitor Facilities Fund or General Fund.

COORDINATION

The acceptance of the grants has been coordinated with the Office of Management and Budget, the Finance Department, the City Attorney's Office and the Cultural Arts Board.
