#### **SUMMARY AND RECOMMENDATIONS**

This ordinance authorizes the City Manager to accept and execute a contract change totaling \$305,776.00 from the Texas Department of State Health Services (DSHS) to renew funding for the ongoing Local Public Health Support Program in the San Antonio Metropolitan Health District (SAMHD) for the period September 1, 2004 through August 31, 2005. This ordinance will also adopt the program budget and approve the personnel complement.

Staff recommends approval.

#### **BACKGROUND INFORMATION**

The City Manager was authorized to execute the Public Health State Support Project 2004/2005 contract with DSHS through an ordinance passed and approved on December 4, 2003 providing annual assistance to the City in support of the core public health activities provided by the SAMHD. DSHS has now offered a contract change totaling \$305,776.00 through Contract Change Notice No. 13 to renew support for the ongoing Local Public Health Support Program in the SAMHD for the period September 1, 2004 through August 31, 2005 (See Attachment II).

The funding last year included support for two (2) programs in the SAMHD: \$251,464.00 in financial assistance to renew the ongoing Local Public Health Support Program and \$54,312.00 in-kind support to renew the Public State In-Kind Support Program. The Local Public Health Support Program funded five (5) positions working in a variety of local public health activities to include: the implementation of a community health improvement plan, public relations, supervision of the TB clinic and other functions. The Public Health In-Kind Support Program activity supported one (1) state paid position that was permanently located in the SAMHD Laboratory. This brought the total personnel support for this grant last year to six (6) positions.

This year DSHS has offered a combined funding support at the same dollar value as last year. Based on this combination, the DSHS in-kind position from last year has been eliminated and a new grant funded City position, a Laboratory Technologist II, was created. Therefore, the personnel complement for this activity remains at six (6) positions (See Attachment I). Acceptance of this contract change brings the total funding for the Public Health State Support Project 2004/2005 Federal and State component to \$2,003,777.00.

#### **POLICY ANALYSIS**

Acceptance of this grant from DSHS will continue the long-standing practice of utilizing Federal and State aid to support the local public health programs of the City.

#### FISCAL IMPACT

This contract change provides support totaling \$305,776.00 to renew the ongoing Local Public Health Support Program in the SAMHD for the period September 1, 2004 through August 31, 2005. Acceptance of this grant will place no demand on the City General Fund.

#### **COORDINATION**

The City Attorney's Office and the Human Resources Department, Risk Management Division, have reviewed and approved the contract with DSHS. The Finance Department has approved the proposed budget.

#### **SUPPLEMENTARY COMMENTS**

Provisions of the Ethics Ordinance do not apply.

SECTION I. SCOPE OF WORK:

PERFORMING AGENCY shall improve or strengthen local public health infrastructure within the State of Texas by:

- Developing objective(s) to address a public health issue;
- Utilizing resources provided through this contract attachment to conduct activities and services that provide or support the delivery of essential public health services;
- Assessing, monitoring, and evaluating the essential public health activities and services provided through this contract attachment; and
- Developing strategies to improve the delivery of essential public health service(s) to identified service area.

These tasks shall be performed in accordance with PERFORMING AGENCY'S FY 05 Local Public Health System (LPHS) Service Delivery Plan, dated May 27, 2004 and the FY 05 Texas Application for Preventive Health and Health Services Block Grant Funds, dated June 15, 2004.

The assessment and/or evaluation activities must include a standard that is identified in PERFORMING AGENCY'S FY 05 LPHS Service Delivery Plan. Acceptable standards include the National Public Health Performance Standards approved by the Centers for Disease Control and Prevention, Performance Standards developed by the Texas Association of Local Health Officials, Healthy People 2010, and any federal, state or local law or regulation governing the delivery of essential public health services. Other evaluation methods utilizing standards not listed in this contract Attachment must be pre-approved by RECEIVING AGENCY.

PERFORMING AGENCY shall comply with all applicable federal and state laws, rules, regulations, standards including, but not limited to, the following:

- Chapter 23-11 of the Healthy People 2010;
- Section 121.002, Texas Health & Safety Code, definition of ten essential public health services; and
- Government Code, Section 403.1055, "Permanent Fund for Children and Public Health".
- Texas Administrative Code, Title 25, Chapter 83, Subchapter A "Permanent Fund for Children and Public Health".

PERFORMING AGENCY shall comply with all applicable regulations, standards, and guidelines in effect on the beginning date of this contract Attachment.

The following documents are incorporated by reference and made a part of this contract Attachment:

- PERFORMING AGENCY'S FY 05 LPHS Service Delivery Plan; and
- FY 05 Texas Application for Preventive Health and Health Services Block Grant Funds.

PERFORMING AGENCY may not use funds from the Permanent Fund for Children and Public Health for lobbying expenses under the Government Code, Section 403.1067.

RECEIVING AGENCY shall inform PERFORMING AGENCY in writing of any changes to applicable federal and state laws, rules, regulations, standards and guidelines. PERFORMING AGENCY shall comply with the amended law, rule regulation, standard or guideline except that PERFORMING AGENCY shall inform RECEIVING AGENCY Program in writing if it shall not continue performance under this Attachment within thirty (30) days of receipt of an amended standard(s) or guideline(s). RECEIVING AGENCY may terminate the Attachment immediately or within a reasonable period of time as determined by RECEIVING AGENCY.

#### PERFORMANCE MEASURES

PERFORMING AGENCY shall complete the PERFORMANCE MEASURES as stated in the FY 05 LPHS Service Delivery Plan, and as agreed upon by RECEIVING AGENCY, and hereby attached as Exhibit A.

PERFORMING AGENCY shall provide activities and services as submitted by PERFORMING AGENCY and approved by RECEIVING AGENCY in the FY 05 LPHS Service Delivery Plan in the following county(ies)/area: Bexar.

#### SECTION II. SPECIAL PROVISIONS:

General Provisions, Reports Article, is revised to include the following paragraphs:

PERFORMING AGENCY shall submit quarterly progress reports which describe progress toward completing the activities and services contained in PERFORMING AGENCY'S FY 05 LPHS Service Delivery Plan and any written revisions. PERFORMING AGENCY shall submit the first, second and third quarter's progress reports to RECEIVING AGENCY no later than thirty (30) days after the end of each quarter, and the final report and improvement plan to RECEIVING AGENCY sixty (60) days after the end of this contract Attachment term in a format specified by RECEIVING AGENCY.

PERFORMING AGENCY shall submit an Annual Budget and Expenditures Report in a format specified by and to RECEIVING AGENCY by December 15, 2005.

#### **PERFORMANCE MEASURES:**

PERFORMING AGENCY: San Antonio Metropolitan Health District

**Issue:** Coordinating the administration of public health services done through the Office of the Director of Health.

Objective #1: PERFORMING AGENCY shall receive complaints and requests for service related to public health that have been forwarded through the San Antonio City Council and coordinate staff efforts to resolve.

**Performance Measure:** 100% of all complaints and requests for service obtained from the San Antonio City Council ("blue blazers") will be coordinated, tracked and satisfactorily closed within one (1) working day.

**Objective #2:** PERFORMING AGENCY shall ensure that contracts have been appropriately executed and filed.

**Performance Measure:** 100% of all contracts will be executed within the timeframes set by City policy.

Issue: Coordinate clinical supplies, specimen collection, input of demographics, and the clinical analysis of CLIA Waived procedures.

Objective #1: PERFORMING AGENCY shall receive specimens and requests submitted to the Laboratory from Health District Clinics and provide testing in accordance with CLIA.

**Performance Measure:** Employee will provide CLIA Waived testing in accordance with CLIA regulations.

Objective #2: PERFORMING AGENCY shall fill and record clinic supply orders as received on a daily basis.

**Performance Measure:** 100% of clinical supplies ordered will be sent to the clinic upon receiving its request.

Objective #3: PERFORMING AGENCY shall input patient demographic data into the Laboratory Information System as the specimens arrive at the Main Laboratory.

**Performance Measure:** Employee must enter patient data upon receipt of specimen into the Laboratory Information System in accordance to the Policies and Procedures of the Central Receiving Section.

**Objective #4:** PERFORMING AGENCY shall provide phlebotomy procedures for all patients referred to the Main Laboratory.

**Performance Measure:** Employee must provide phlebotomy related procedures for walk-ins to Main Lab, and special projects with little or no notice.

Issue: Providing public health information to the community.

Objective #1: PERFORMING AGENCY shall develop multimedia messages to build community awareness of public health issues utilizing press releases, press conferences, editorial commentary, magazine or journal articles and special events.

**Performance Measure:** Multimedia messages will be developed to build public awareness of public health issues.

Objective #2: PERFORMING AGENCY shall produce "To Your Good Health" cable television series.

**Performance Measure:** The cable television series "To Your Good Health" will be produced.

**Objective #3:** PERFORMING AGENCY shall design and place advertising materials using local and neighborhood print outlets, billboards, public service announcements on radio and television, and bus advertisements featuring Health District Programs and projects.

Performance Measure: Advertising materials will be designed and placed.

**Issue:** Adult Preventive Health – Prevention of chronic disease among women including but not limited to breast and cervical cancer.

Objective 1.1: PERFORMING AGENCY shall further develop and implement programming directed toward preventing adult chronic disease including but not limited to breast and cervical cancer.

Performance Measure 1.1: Number of programs directed toward the prevention of adult chronic disease including screening events, educational events and client contacts.

**Objective 1.2:** PERFORMING AGENCY shall evaluate the success of program events directed toward the prevention of adult chronic diseases including but not limited to breast and cervical cancer.

**Performance Measure 1.2:** Number of women identified through screening programs and subsequently linked to needed health services.

**Objective 2.1:** PERFORMING AGENCY shall form community partnerships to develop strategies to engage women in good preventive health practices.

Performance Measure 2.1: Number of community coalition meetings and activities devoted to women's chronic disease issues.

Issue: 1) Carry out community wide strategic planning process for health improvement called "Mobilizing for action through Planning and Partnerships (MAPP)". 2) Facilitate the implementation of a local public health system improvement plan for San Antonio and Bexar County. 3) Seek relevant and appropriate grant opportunities for health improvement.

**Objective #1:** PERFORMING AGENCY shall provide leadership and direction to the local public health system (LPHS) partners in San Antonio and Bexar County in carrying out the MAPP process.

**Performance Measure:** Complete all phases of MAPP and document process.

**Objective #2:** PERFORMING AGENCY shall coordinate collaboration among public health partners to implement improvement plan, addressing the six strategic public health issues for San Antonio and Bexar County.

**Performance Measure:** Implement LPHS improvement plans for each of the identified strategic public health issues.

**Objective #3:** PERFORMING AGENCY shall seek opportunities to collaborate with LPHS partners to pursue funding opportunities in support of MAPP and the LPHS improvement plan.

**Performance Measure:** Apply for grant funding in support of MAPP and the LPHS improvement plan. Compile all activities of MAPP process into a comprehensive report.

Issue: Supervise Central Services, Central Receiving, and monitor procurement and budget activities.

Objective #1: PERFORMING AGENCY shall generate purchase requisitions, Request for Payments (RFP PO), and Annual Contracts for Laboratory Supplies

and Services to include typing, budget considerations, tangibles/services followup backup file management and all payment and petty cash initiation.

**Performance Measure:** Employee will provide laboratory with supplies, equipment, and payments in a timely manner, to aid in overall lab efficiency.

Objective #2: PERFORMING AGENCY shall supervise Central Service Section of Laboratory in relation to maintenance, QA/QC, and record keeping for sterilization, dry heat ovens, and steam sterilizers, water deionizer equipment, and waste management of sharps and other medical waste.

**Performance Measure:** Maintain laboratory certification, QA/QC, and record keeping requirements related to CLIA, and the Department of State Health Services (DSHS).

Objective #3: PERFORMING AGENCY shall liaison between Laboratory and vendors, post office, UPS, FedEx, Nursing Services, STD, Print Ship, Purchasing Dept, Equipment Service Entities, Laboratory Proficiency Services, DSHS, for supported supplies and the generation of the laboratory monthly reports.

**Performance Measure:** Coordinate with external points of contact any communication necessary for effective cooperative services.

Objective #4: PERFORMING AGENCY shall supervise the Central Receiving Section relating to patient/data entry, specimen preparation procedures and the distribution of specimens to appropriate sections.

**Performance Measure:** To perform corrective action, and design development to the multiple LIMS to achieve greater efficiencies. (Example: turn-around time).
