SUMMARY AND RECOMMENDATIONS:

COORDINATION:

This event has been coordinated with the City Manager's Office, the Traffic Section of the Police Department, and the Traffic Division of the Public Works Department. All of the involved city departments concur with the staff recommendation to approve this request.

FINANCIAL IMPACT:

All insurance requirements, public safety devices (signs, barricades) and any off-duty police as may be required by the Police Department or the Public Works Department shall be the responsibility of the event sponsor, Scobee Elementary School (NISD). The City will receive revenues of \$25.00 from this event and will incur no additional costs.
