SUMMARY AND RECOMMENDATIONS

This ordinance authorizes an extension of the Fiesta Carnival and Parade Route Concessions Contract between Fiesta San Antonio Commission, Inc. and Reed Exposition Midway for an additional two (2) years to include the 2005 and 2006 Fiesta years and with modified pricing, as requested by the Fiesta San Antonio Commission, Inc.

Staff recommends approval of this ordinance.

BACKGROUND INFORMATION

The City has a ten year contract with the Fiesta San Antonio Commission, Inc. to coordinate, oversee and provide financial payment to the City for Fiesta. The contract was approved in 1998 for Fiesta years 1999-2008.

Fiesta San Antonio Commission, Inc., in turn, contracts with an operator to provide the Fiesta Carnival and Parade Route Concessions, which is selected through an RFP process. City staff assists with the RFP process and City Council approves the final selection that is recommended by the Commission. In 2001, a three-year contract was approved with Reed Exposition Midway. The expiring contract allows an option to extend the contract for an additional two (2) years. The Commission has notified the City that it has exercised the option to extend the contract with Reed. The contract extension requires City Council approval. If the City Council does not approve, then the Commission must advertise an RFP for a new vendor.

The Commission and City staff have no concerns with the performance of Reed Exposition Midway during the past three (3) Fiesta events. Reed has requested some price increases for the extension period, which is the first request to change prices approved in the 2001

agreement. The proposed price changes are shown on Exhibit 1. Spectacular Rides will increase by \$0.50 to \$3.50 each, Major Rides will increase by \$0.75 to \$3.00 each and Kids' Rides will remain at the current price of \$1.50 each. Several food/beverage items have price increases of \$0.25 or \$0.50 but the majority of the prices will not change. Everything is sold by tickets and the ticket price will change from \$0.75 to \$0.50 each. Reed Exposition Midway operates concessions at the Wisconsin State Fair and the Lubbock South Plains Fair. A comparison of prices charged in those locations shows that San Antonio prices are lower overall.

During the Fiesta event, the City provides final approval of the Carnival and Concessions activities locations and inspects final clean up. If the areas are not cleaned satisfactorily, then the City may access a \$50,000.00 Performance Bond required from the contractor. Both the Fiesta Commission and the Carnival and Concessions contractor must indemnify the City. Fiesta San Antonio Commission, Inc. provides an audit to the City by December 31 of each contract year, which has been reviewed and has no outstanding issues. The Carnival and Concessions operator must provide an audit to the Commission within 90 days following the end of Fiesta, which also has been reviewed and has no outstanding issues.

POLICY ANALYSIS

The contract was approved in 1998 for Fiesta years 1999-2008. In 2001, a three-year contract with an option for an additional two years was approved with Reed Exposition Midway. The proposed extension with price changes was presented to the Quality of Life Committee on October 7, 2004 and the Committee concurred with this action.

FISCAL IMPACT

Contract payment terms will remain the same. 35% of gross revenues, or a minimum of \$750,000.00, is paid to the Fiesta Commission by Reed Exposition Midway.

The City receives reimbursement for costs and expenses incurred in connection with Fiesta, as specified in the Fiesta Commission agreement. The amount reimbursed is dependent upon the revenue collected by the Commission. In each of the past three years, the City received payment of \$150,000.00 from the minimum guaranteed payment of \$750,000.00 by Reed Exposition Midway to Fiesta Commission.
