Through this memo I am making some adjustments to existing Council Committee and Board and Commission Appointments as first outlined in my memo of August 4, 2003, effective this date.

Council Member representation to Boards and Commission:

City Council will resume regular meetings and City Council committee meetings this month. Through this memo I hope to clarify the functions and responsibilities of the City Council committees and the logistics of committee meetings. Committees should serve as an opportunity for staff to receive policy guidance from City Council while programs and projects are under development, and for briefings on ongoing issues. Committee meetings also allow staff to hear and address Council members' and stakeholders' concerns before presentation to the full council and the public.

The process for the Council committee meetings is as follows:

- o The committee Chairs are responsible for setting meeting agendas and calling meetings.
- o A Master Calendar has been established through Gayle McDaniel's office. Any changes to that schedule should be reported to her as promptly as possible.
- o The City Manager has assigned her staff to support each committee by assisting with scheduling, posting notice, distributing the agenda and keeping minutes.
- o The City Attorney will provide a template for committee agendas.
- All Council members will receive copies of all committee agendas, whether or not they serve on a particular committee. Council members may wish to assign aides to attend the meetings of committees on which they do not serve.
- O City Council members may grant aides the authority to attend meetings of committees on which they do serve. Aides may request information or make statements, but may not vote or participate in discussion.
- Please remember to copy Executive Secretaries on your communications to Council members.

A final list of appointments to the Council committees and to other boards and commissions is attached.

In consultation with the committee chairs, I have developed the following charges to the committees for the coming year.

## **Economic and Human Development**

Councilman Enrique Barrera will lead the Economic and Human Development Committee, responsible for programs and initiatives that support education, development in targeted industries and creating a competitive economy. I will coordinate with the committee to target the recruitment of Fortune 500 companies through creation of an Economic Development Incentive Fund. Other supports, such as the Incentive Tool Kit, will focus on small and mid-sized business recruitment and expansion.

I will collaborate with the Economic and Human Development Committee to create a focused program of education, industry and economic development incentives that advances the goals of SA Inc, our economic development plan. Perhaps most importantly, we must invest in our human capital and other existing resources--such as Brooks City Base, KellyUSA, the UTHSC and our medical center--to ensure that San Antonio is a leader in bio-medical research, computer and information security, homeland defense, telecommunications and aviation/aerospace. These industries form the basis for preparedness enterprise, and San Antonio has a real opportunity to become a global competitor in this field.

During the next year, the Economic and Human Development Committee will partner with UTSA and the Texas A&M system to achieve two goals—a flagship UTSA campus and a four-year A&M campus on the south side of San Antonio. The committee will also address programs and projects related to health—such as the Fit City Initiative; social services—such as my ad hoc Hunger and Homelessness task force and Day Labor task force; domestic abuse; and family strengthening. Finally, this committee will work with the tourism industry to develop a culinary arts facility for San Antonio, as well as address issues relating to a Convention Center Hotel.

#### Governance

I will continue to serve as chair of the Governance Committee, which will be responsible for ongoing functions such as agenda planning, financial matters, personnel, audit and contract monitoring and ethics reform. The committee will also be responsible for special efforts such as ERM/CRM oversight, review of the City Manager, and charter reform. The City Auditor and City Clerk will continue to report to Council through this committee.

#### Inter-Governmental Relations

Councilman Julian Castro will serve as chair of the Inter-Governmental Committee, whose mission encompasses relationships and initiatives with local, state and federal governments and agencies. During the special session or sessions of the 78<sup>th</sup> Legislature, this committee will review and respond to legislation that affects the City of San Antonio. Inter-Governmental Relations is also responsible for coordination with other local governmental entities, including Bexar County, VIA, ACCD and school districts. Inter-Governmental Relations has oversight of City-County joint service agreements.

#### International Relations

International Relations, led by Councilman Barrera, will continue to seek opportunities for economic development in other countries and to oversee business exchanges. While relationships with Japan have become much more significant, the committee will also seek to strengthen relationships and trade with Mexico and other established partners. This committee will coordinate with the Free Trade Alliance, the Chambers of Commerce and the World Trade Council to position San Antonio as a logistics center for international trade, and with the CVB to attract international travel. International Relations will continue to support San Antonio as the home of the NAD Bank.

## Military Affairs

Councilman Carroll Schubert will chair the Military Affairs Committee, which will take the lead on preparing for 2005 base closure/EFI activities. During the next year, the committee will work with the Chambers of Commerce to further develop our strategy for protecting San Antonio's installations, including innovative privatization efforts at Brooks City Base and Ft. Sam Houston. Also critical are efforts to strengthen the position of military medical facilities such as the trauma centers at BAMC and Wilford Hall.

## **Quality of Life**

The Quality of Life Committee will also be led by Councilman Carroll Schubert and will cover issues including environmental quality, infrastructure (including Neighborhood Improvement Districts), transportation (including airports and related issues) and public safety. A designated subcommittee will oversee municipal courts. The Quality of Life Committee will be responsible for arts and culture, including the Cultural Arts Plan; community facilities, including the Alamodome and the Tower of the Americas; and animal care, including plans for a new animal care facility.

During the next year, the Quality of Life Committee will consider the effectiveness of Proposition 3 and make a recommendation on expansion or extension of a publicly funded program to purchase sensitive lands over the recharge zone. The committee will also guide the planning process for the creation of the Edwards Aquifer Management Model, including building partnerships with other agencies and governments and coordinating funding. Other GIS models—such as that being prepared for the Medical Center area—will also come under the oversight of the committee.

As part of their transportation charge, the Quality of Life Committee will coordinate with SAMCo and the Austin-San Antonio Corridor Council, and will work with AACOG's AIRCo to map out a vehicle emissions testing strategy for San Antonio.

#### **Urban Affairs**

The Urban Affairs Committee will be responsible for issues affecting the vitality of neighborhoods and downtown. Under the leadership of Councilman Castro, the committee will review all programs and policies related to housing, balanced growth and support for small business. The committee is the designated point of contact for the San

Antonio Housing Authority and will have oversight of issues related to the redevelopment of the former Victoria Courts. Urban Affairs will also handle annexation, including oversight of the Southside Initiative.

During the coming year, Urban Affairs will oversee the implementation of the Incentive Tool Kit; the Neighborhood Commercial Revitalization (NCR) program review; the Historic Civic Center plan; the ongoing historic building inventory; the downtown housing market study; and CRAG initiatives related to the 36 square-mile target area. In addition, the Urban Affairs Committee will monitor the revision of guidelines for the Tax Increment Financing/Reinvestment Zones. This committee is responsible for UDC implementation, such as developing a proposal for a maximum-setback commercial zoning classification and oversight of the revised Tree Preservation ordinance.

I look forward to working with each of you during the coming year to accomplish these goals and those that you bring to your committees' work.
