SUBJECT: Funding for Solar San Antonio, Inc.

DATE: October 27, 2004

I respectfully request your support in directing staff to place an action item on a forthcoming City Council agenda reallocating \$5,000 of the Mayor's FY 2001 One-Time Project funds for a grant contribution to Solar San Antonio, a non-profit advocacy and resource center for renewable and sustainable energy applications in order to support their ongoing educational programs involving the public school system. Additionally, I request your support in contributing \$2,000 from each City Council Districts' FY 2005 Human Development Services Funds toward the total grant contribution for Solar San Antonio. The combined allocation from the Mayor and each City Council Member would provide a total of \$25,000 for Solar San Antonio. Solar San Antonio's mission includes providing energy options that decrease energy costs for San Antonio and South Texas through use of solar and other renewable energy sources.

Specifically regarding the Mayor's FY 2001 One-Time Project funds, this request redirects \$1,231.86 from the completed Creekway and Linear Park Development Report project and \$3,768.14 from the completed Emissions Device Testing project.

AN ORDINANCE

REALLOCATING \$5,000.00 FROM THE MAYOR'S FY 2001 ONE-TIME PROJECT FUNDS AND AUTHORIZING THE FOLLOWING ADJUSTMENTS; REDUCING FUNDS SET ASIDE FOR THE COMPLETED CREEKWAY AND LINEAR PARK DEVELOPMENT REPORT PROJECT BY \$1,231.86; REDUCING FUNDS SET ASIDE FOR THE COMPLETED EMISSIONS DEVICE TESTING PROJECT BY \$3,768.14; AND ALLOCATING \$5,000.00 TO SOLAR SAN ANTONIO, A NON-PROFIT ADVOCACY AND RESOURCE CENTER FOR RENEWABLE AND SUSTAINABLE ENERGY APPLICATIONS IN ORDER TO SUPPORT THEIR ONGOING EDUCATIONAL PROGRAMS INVOLVING THE PUBLIC SCHOOL SYSTEM; AS REQUESTED BY MAYOR EDWARD D. GARZA

WHEREAS, Mayor Edward D. Garza has received a request from Solar San Antonio, a non-profit advocacy and resource center seeking public funds for renewable and sustainable energy applications in order to support their educational programs involving public school systems. Solar San Antonio's mission includes providing energy options that decrease energy costs for San Antonio and South Texas through use of solar and other renewable energy sources. These funds would off-set certain expenses which City Council hereby finds support municipal public purposes; and

WHEREAS, a sufficient balance exist in the Mayor's FY 2001 One-Time Project fund by allocating adjustments reducing funds in the amount of \$1,231.86 set aside for the completed Creekway and Linear Park Development Project and reducing funds in the amount of \$3,768.14 set aside for the completed Emissions Device Testing Project to support this request, which balances must now be reallocated for these purposes; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The request of Solar San Antonio which is attached to this ordinance as Exhibit I, is hereby approved.

SECTION 2. The City Manager or a designee, is hereby authorized for a period of sixty (60) days from the effective date of this ordinance, to execute an agreement with said agency which will set out the terms and conditions for receiving and using public funds. Substantially final copies of this agreement is attached to this ordinance as Exhibit 2 and will be replaced with a fully executed agreement upon final execution by the party.

SECTION 4. The budget in Fund _____ (_____) entitled "Emissions Device Testing Project" is authorized to be reduced by \$3,768.14.

SECTION 5. Funds in the amount of \$5,000.00 are authorized to be appropriated in Fund _____ (_____) in Index Code _____ entitled "_____" and made payable to Solar San Antonio, a non-profit advocacy and resource center for renewable and sustainable energy applications in order to support their ongoing educational programs involving the public school system.

SECTION 6. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific index codes and fund numbers as necessary to carry out the purpose of this Ordinance

SECTION 7. This ordinance shall take effect on the tenth (10th) day after the date of passage hereof.
