SUMMARY AND RECOMMENDATIONS

This ordinance authorizes the Interim City Manager or his designated representative to accept a U.S. Department of Justice, Office of Community Oriented Policing Services (COPS) grant in the amount of \$164,819.00, for the Methamphetamine Training Initiative administered by the San Antonio Police Department which will enhance methamphetamine related prevention, enforcement, and education programs. The grant period is August 1, 2004 to January 31, 2006.

Staff recommends approval.

BACKGROUND INFORMATION

The mission of the Methamphetamine Training Initiative is to reduce the growing trend of methamphetamine production and use in the San Antonio metropolitan area by implementing programs in enforcement, prevention, and education programs.

The San Antonio Police Department has noticed an increasing trend in the number of clandestine methamphetamine labs and use of the drug. Since January 2002 the number of methamphetamine labs encountered by the SAPD Narcotics Unit has increased sixteen percent (16%) and the amount of methamphetamine seized has increased one hundred ten percent (110%).

The grant targets methamphetamine production by intelligence gathering to identify repeat offenders and common locations of the labs. It will also provide enhanced training for the Department's investigators designed to improve their skills in investigating methamphetamine labs, preparing cases for prosecution, and to certify investigators. Additionally, it helps to develop a partnership with the community by increasing public knowledge of methamphetamine production and use. This will result in more effective prosecution that will in turn reduce the production and use of methamphetamine within our jurisdiction.

Although the grant period is August 1, 2004 through January 31, 2006, the San Antonio Police Department received an invitation from the U.S. Department of Justice, Office of Community Oriented Policing Services on June 22, 2004, to apply for the Methamphetamine Training Initiative grant. The SAPD did not receive the grant application package until July 21, 2004 and was awarded the grant on November 2, 2004, after the starting date of the grant. City Ordinance No. 99591, dated September 19, 2004 authorized the submission of the grant.

POLICY ANALYSIS

This Ordinance continues City Council's policy of seeking intergovernmental financial assistance for City crime prevention and enforcement programs addressing drug crime activity. This program will enhance the City's efforts in dealing with methamphetamine use and production in our community.

FISCAL IMPACT

The program budget totals \$164,819.00. A General Fund cash match is not required.

COORDINATION

This ordinance request has been coordinated with the Finance Department, the City Attorney's Office, and the Office of Management and Budget.
