SUMMARY & RECOMMENDATION

This ordinance authorizes the Purchasing & General Services Department to accept the proposal submitted by Graybar Electric Company utilizing U.S. Communities Government Purchasing Alliance to provide the City of San Antonio Information Technology Services Department with an annual contract for telecommunications supplies for an estimated annual total of \$280,414.07. Staff recommends approval of this ordinance.

BACKGROUND INFORMATION

In February 2004, Ordinance No. 98797, the City entered into an Intergovernmental Cooperative Purchasing Agreement with U.S. Communities Government Purchasing Alliance. The Intergovernmental Agreement allows the City to utilize goods and services procured by its participating member entities. The resultant contract for telecommunication supplies was awarded to Graybar Electric Company for a period of two years, effective January 1, 2005 and terminates December 30, 2007 with two one-year options to extend.

This contract will be utilized by the City of San Antonio Information Technology Services Department for the annual purchase of cabling and related hardware used for computer network and communication systems throughout City facilities. The estimated annual cost of this contract is \$280,414.07.

POLICY ANALYSIS

The City of San Antonio Information Technology Services Department provides technical, networking and telecommunication assistance to all City departments. This contract will provide for the purchase of necessary parts and supplies on an as needed basis, which are required for the maintenance and repair of computer networks and communication systems.

FISCAL IMPACT

The estimated annual cost of this contract is \$280,414.07 annually. Funding will be not be encumbered by the ordinance. All expenditures will be in accordance with the FY2004-2005 Budget approved by City Council.

COORDINATION

This item has been coordinated with the City of San Antonio Information Technology Services Department.
