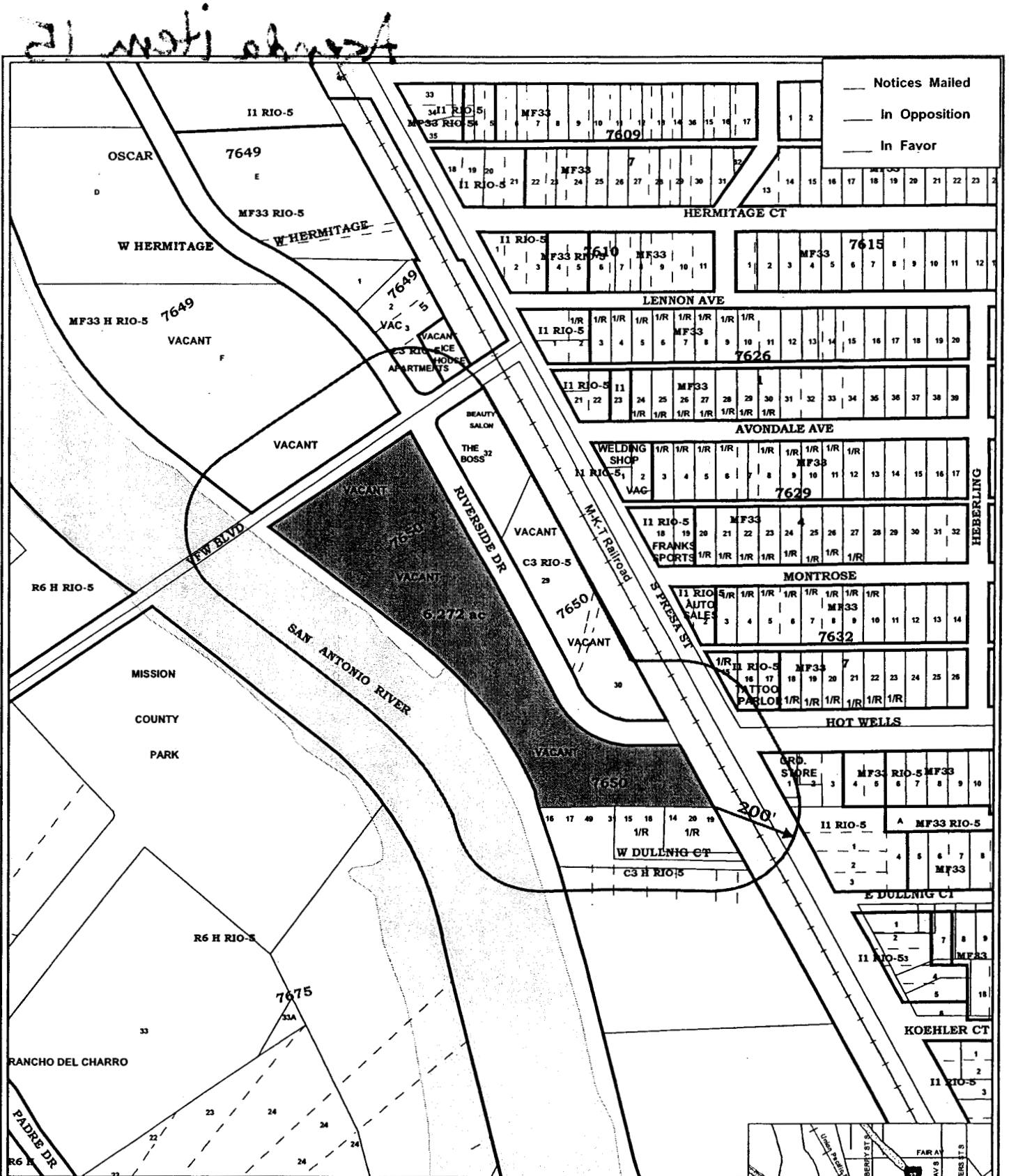

TIA Statement: A Traffic Impact Analysis is not required.

Staff Recommendation:

Consistent. The South Central San Antonio Community Plan identified this area for Transit-Oriented Development. Transit-Oriented Development is described in the plan as providing higher density land uses to encourage transit rider ship.

Approval. An MF-33 Multi-Family District designation may be applied to a use in a multi-family residential area located near supporting transportation and commercial facilities. The subject property is adjacent to MF-33 H RIO-5 Historic Multi-Family District, River Improvement Overlay across VFW Boulevard to the north, C-3 H RIO-5 Historic General Commercial District, River Improvement Overlay across Riverside Drive to the northeast and the San Antonio River to the southwest. The MF-33 H RIO-5 Historic Multi-Family District, River Improvement Overlay would be appropriate at this location. The subject property is to be developed in conjunction with the land across VFW Boulevard to the north.

Applicant: Earl & Associates, P. C.

Zoning Request: H "C-3" RIO-5 Historic General Commercial District, River Improvement Overlay to H "MF-33" RIO-5 Historic Multi-Family District River Improvement Overlay.

Buck Benson, 111 Soledad, representing the owner, stated the purpose of this request to allow for multi family development on the subject property. He stated they have visited with the surrounding neighbors who are in support of this development. He has also collected a petition with 500 signatures expressing their support. This development would include all amenities such as computer room, swimming pools and a clubhouse.

FAVOR

Lawrence Seiterle, 118 Broadway, #324, stated he has met with Mr. Benson to further discuss their proposal and is in support. He stated he feels this new development would enhance the appearance of the community.

Gloria R. Cortez, 5300 S. Presa, stated she supports new development for this area. She stated the subject property has been vacant for many years and has become a dumping site. She feels this development would be a start for improving the neighborhood.

Jim Myers, 5539 Cove Valley, representing the Southside Chamber of Commerce, stated they strongly support this development. He stated this area is in need of new development and feels the proposed development would enhance the community.

Heather Ayala, 115 Harcourt, stated she feels affordable housing is crucial in South San Antonio. She feels this would be good for the neighborhood.

Craig Bloom, 228 Losoya, representing Avienda's Group, stated he feels this new development would uplift this area and feels this development would serve the community positively.

Ralph Ortiz, 706 Vickers, stated he is in favor of the proposed development.

Isidro Solis, 9223 Garnett, stated he feels this area is appropriate for the proposed development. He stated he has visited with the surrounding residence and they are all in support.

Laura Garcia, 7110 Symphony, stated she is also in support of this request.

Frank Ortiz, 507 Briggs, stated he would also like to express his support of this request. He feels this would be good for the community.

Ruben Pena, 257 E. Mayfield, stated he would like to express his support for the proposed development. He stated he encourages new development for the South Side of San Antonio.

Staff received a verbal approval from Mission San Jose Neighborhood Association and Riverside Neighborhood Association is in favor.
