**SUMMARY AND RECOMMENDATIONS:**

This ordinance will approve the parade permit and authorize the temporary closure of certain streets in connection with the St. Patrick's Day Parade being held on Saturday, March 12, 2005. The run/walk will assemble at Avenue E between Third and Brooklyn and disband at Presa between Market and Nueva in La Villita. The route is attached.

Staff recommends approval of this ordinance.

**POLICY ANALYSIS:**

This ordinance is consistent with the City policy requiring an ordinance where closures of public streets are requested.

**COORDINATION:**


This event has been coordinated with the City Manager's Office, the Traffic Section of the Police Department, and the Traffic Division of the Public Works Department. All of the involved city departments concur with the staff recommendation to approve this request.


**FINANCIAL IMPACT:**
